Laleham Gap – A Unicef Rights Respecting School

Laleham Gap is a Unicef Rights Respecting School. We learn, teach and live the United Nations Convention on the Rights of the Child (UNCRC).

The following articles underpin our beliefs about child protection:

- Article 1: Everyone under the age of 18 is a child and has all the rights in the Convention.
- Article 2: The Convention applies to every child without discrimination, whatever their ethnicity, gender, religion, language, abilities or other status, whatever they think or say, whatever their family background.
- Article 3: The best interests of the child must be a top priority in all decisions and actions that affect children.

- Article 6: Every child has the right to life. Governments must do all they can to ensure that children survive and develop to their full potential.
- Article 12: Every child has the right to express their views, feelings and wishes in all matters affecting them, and to have their views considered and taken seriously.
- Article 16: Every child has the right to privacy. The law should protect the child's private, family and home life, including protecting children from unlawful attacks that harm their reputation.
- **Article 19: Governments must do all they can to ensure that children are protected from all forms of violence, abuse, neglect and bad treatment by their parents or anyone else who looks after them.**
- Article 20: If a child cannot be looked after by their immediate family, the government must give them special protection and assistance. This includes making sure the child is provided with alternative care that is continuous and respects the child's culture, language and religion.
- Article 24: Every child has the right to the best possible health. Governments must provide good quality health care, clean water, nutritious food and a clean environment and education on health and well-being so that children can stay healthy.
- Article 25: If a child has been placed away from home for the purpose of care or protection (for example, with a foster family or in hospital), they have the right to a regular review of the treatment, the way they are cared for and their wider circumstances.
- Article 32: Governments must protect children from economic exploitation and work that is dangerous or might harm their health, development or education.
- Article 33: Governments must protect children from the illegal use of drugs and from being involved in the production and distribution of drugs.
- Article 34: Governments must protect children from all forms of sexual abuse and exploitation.
- **Article 36: Governments must protect children from all other forms of exploitation, for example, the exploitation of children for political activities, by the media or for medical research.**
- **Article 39: Governments must protect children from all forms of sexual abuse and exploitation.**

Laleham Gap also observes other key legislation and international agreements, including The Human Rights Act 1998, The Equality Act 2010 and The Public Sector Equality Duty (PSED) highlighted in KCSIE.

What to Do If you Have a Welfare Concern

Why are you concerned?

For example:

- Something a child has said, for example, an allegation of harm
- Child's appearance; may include (frequent) unexplained marks/bruises and/or dress
- Behaviour change(s)
- Witnessed concerning, harmful or inappropriate behaviour

Act immediately and record your concerns: If urgent, speak to a DSL first

Follow the school procedure – see section 3 of the Child Protection Policy

- Reassure the child
- Clarify any concerns using open questions, if necessary (TED: Tell, Explain, Describe)
- Use CPOMS and record facts, and not opinions.
- Use the child's own words
- Seek support for yourself as required from a DSL (Joshua Payne or a Deputy DSL)

Inform the Designated Safeguarding Lead: Joshua Payne – Ext 500, Beccy Minter – Ext 358

- If a child is at risk of immediate harm and/or is unsafe to go home, make an urgent [Request for Support to the Front Door Service via the portal](#) or call the Police on 999.
- If no immediate risk of harm, provide internal support and/or refer to other agencies in line with [Kent Safeguarding Support Level Guidance and KSCMP procedures](#), as appropriate. For example, signposting to community services and/or early help open access, a non-urgent call to the Police via 101, reporting allegations against staff to the County LADO Service, or make a Request for Support via the [Front Door Service Portal](#).
- If the school believes a child may be in need of support, but are unclear whether to refer, a **no-named consultation** can be sought from the Front Door Service via **03000 411 111**.
- Where support is required out of working hours, the school will contact the Out of Hours Service via **03000 41 91 91**.

If you are unhappy with the response:

DSLs/Staff:

- Follow school whistleblowing procedures which can be access on the staff drive
- Follow Kent [safeguarding partnership escalation](#) procedures.

Leaners or Parents:

- Follow school complaints procedures on the school website.

Record decision making and action taken for the Learner on [CPOMS](#).

Monitor

Be clear about:

- What you are monitoring, for example, behaviour trends, appearance.
- How long you will monitor (e.g. a term, a month, a fortnight).
- Where, how and to whom you will feedback, and how you will record.

Review and request further support if necessary.

At all stages, the child's circumstances will be kept under review
The DSL/staff will request further support if required to ensure the **child's safety is paramount**

1. Child Focused Approach to Safeguarding

1.1 Introduction

- Laleham Gap School recognise our statutory responsibility to safeguard and promote the welfare of all children. Safeguarding and promoting the welfare of children is **everybody's responsibility** and everyone has a role to play. All members of our community (staff, volunteers, governors, leaders, parents, wider family networks, and learners) have an important role in safeguarding children and all have an essential role to play in making our community safe and secure.
- Laleham Gap School believe that the best interests of children always come first (UNCRC Article 3). All children (defined as those up to the age of 18 – UNCRC Article 1) have a right to be heard and to have their wishes and feelings taken into account (UNCRC Article 12) and all children regardless of age, sex (gender), ability, culture, race, language, religion or sexual identity or orientation, have equal rights to protection (UNCRC Article 2).
- Staff working with children at Laleham Gap School will maintain an attitude of **'it could happen here'** where safeguarding is concerned. When concerned about the welfare of a child, staff will always act in the best interests of the child and if any member of our community has a safeguarding concern about any child or adult, they should act and act immediately.
- This policy applies where there are any child protection concerns regarding children who attend Laleham Gap but may also apply to other children connected to the school, for example, siblings, or younger members of staff (under 18s) or children on student/work placements.
- Laleham Gap School recognises the importance of providing an ethos and environment within school that will help children to be safe and to feel safe, helping them to reach their potential and to **learn, grow and succeed**. In our school children are respected and are encouraged to talk openly. We will ensure children's wishes and feelings are taken into account when determining what safeguarding action to take and what services to provide (Article 3, 12).
- Laleham Gap School recognises the importance of adopting a trauma informed approach to safeguarding; we understand there is a need to consider the root cause of children's behaviour and consider any underlying trauma.
- Our core safeguarding principles are:
 - **Prevention:** positive, supportive, safe culture, curriculum and pastoral opportunities for children, safer recruitment procedures.
 - **Protection:** following the agreed procedures, ensuring all staff are trained and supported to recognise and respond appropriately and sensitively to safeguarding concerns.

- **Support:** adopt a child centred approach and provide support for all learners, parents/carers and staff, and where appropriate, implement specific interventions for those who may be at risk of harm.
 - **Collaboration:** with both parents where possible, and other agencies to ensure timely, appropriate communications and actions are undertaken when safeguarding concerns arise.
- The procedures contained in this policy apply to all staff, including governors, temporary or third-party agency staff and volunteers, and are consistent with those outlined within [‘Keeping Children Safe in Education’ 2025](#).

1.2 Policy Context

- This policy is implemented in accordance with our compliance with the current statutory guidance from the Department for Education, ‘Keeping Children Safe in Education’ (KCSIE), which requires individual schools and colleges to have an effective child protection policy.
- This policy has been developed in accordance with the principles established by the Children Acts 1989 and 2004 and related national and local guidance. This includes but is not limited to:

- Section 175 of the Education Act 2002 requires school governing bodies, local education authorities and further education institutions to make arrangements to safeguard and promote the welfare of all children who are learners at a school, or who are students under 18 years of age. Such arrangements will have to have regard to any guidance issued by the Secretary of State.
- Laleham Gap School will follow local or national guidance in response to any emergencies. We will amend this policy and our procedures as necessary but regardless of the action required, our safeguarding principles will always remain the same and the welfare of the child is paramount.
- Laleham Gap School recognises that as a result of the Covid-19 pandemic, some members of our community may have been exposed to a range of adversity and trauma including bereavement, anxiety and in some cases experienced increased welfare and/or safeguarding risks. We will work with local services, such as health and the local authority, to ensure necessary support is in place.

- Laleham Gap School is a Unicef Rights Respecting School. We recognise the need to ensure that all rights taught and maintained within our school to help keep our children safe. All of the rights are relevant to this child protection policy, those which have particular relevance are the following:
 - 3 – Adults must do what's best for me.
 - 19 – I have the right to be protected from being hurt or badly treated.
 - 36 – I have the right to be kept safe from things that could harm my development.
 - 39 – I have the right to help if I have been hurt, neglected or badly treated.

1.3 Definition of Safeguarding

- In line with '[Working Together to Safeguard Children](#)' and [KCSIE](#), safeguarding and promoting the welfare of children is defined for the purposes of this policy as:
 - providing help and support to meet the needs of children as soon as problems emerge
 - protecting children from maltreatment, whether that is within or outside the home, including online
 - preventing impairment of children's mental and physical health or development
 - ensuring that children grow up in circumstances consistent with the provision of safe and effective care
 - promoting the upbringing of children with their birth parents, or otherwise their family network, whenever possible and where this is in the best interests of the child(ren)
 - taking action to enable all children to have the best outcomes.
- Child protection is part of safeguarding and promoting the welfare of all children and is defined as activity that is undertaken to protect specific children who are suspected to be suffering, or likely to suffer, significant harm. This includes harm that occurs inside or outside the home, including online.
- The school acknowledges that safeguarding includes a wide range of specific issues including (but not limited to):
 - Abuse and neglect
 - Bullying, including cyberbullying
 - Child on Child abuse
 - Children with family members in prison
 - Children who are absent or missing from education
 - Children Missing Education (CME)
 - Child missing from home or care
 - Child Sexual Exploitation (CSE)
 - Child Criminal Exploitation (CCE)
 - Contextual safeguarding (risks outside the family home)
 - County lines and gangs
 - Domestic abuse
 - Drugs and alcohol misuse
 - Fabricated or induced illness
 - Faith abuse

- Gender based abuse and violence against women and girls
- Hate
- Homelessness
- Human trafficking and modern slavery
- Mental health
- Nude or semi-nude image sharing, also known as youth produced/involved sexual imagery or “Sexting”
- Online safety
- Preventing radicalisation and extremism
- Private fostering
- Relationship abuse
- Serious violence
- Sexual violence and sexual harassment
- So-called ‘honour-based’ abuse, including Female Genital Mutilation (FGM) and forced marriage
- Upskirting

1.5 Policy Compliance, Monitoring and Review

- Laleham Gap School will review this policy at least annually (as a minimum) and will update it as needed, so that it is kept up to date with safeguarding issues as they emerge and evolve, including lessons learnt. The policy will also be revised following any national or local updates, significant local or national safeguarding events and/or learning, and/or any changes to our own procedures.
- All staff (including temporary staff and volunteers) will be provided with a copy of this policy and Part One of KCSIE as appropriate. There is a folder of Safeguarding Policies and guidance available in the school staffroom, on the website or by request to the DSL.
- Parents/carers can obtain a copy of the school Child Protection Policy and other related policies on request. Additionally, our policies can be viewed via the school website: <https://www.lgs.kent.sch.uk>
- The policy forms part of our school development plan and will be reviewed annually by the governing body who has responsibility for oversight of safeguarding and child protection systems.
- The Designated Safeguarding Lead (DSL) and Headteacher will ensure regular reporting on safeguarding activity and systems to the governing body via termly audits, self-reviews and peer to peer evaluations with KsENT Schools. The governing body will not receive details of individual learner situations or identifying features of families as part of their oversight responsibility.

2. Key Responsibilities

2.1 Governance and Leadership

- The governing body and leadership team have a strategic responsibility for our safeguarding arrangements and will comply with their duties under legislation. The governing body have regard to

the KCSIE guidance and will ensure our policies, procedures and training is effective and complies with the law at all times.

- The governing body will facilitate a whole school approach to safeguarding which involves everyone. They will ensure that safeguarding and child protection are at the forefront and underpin all relevant aspects of process and policy development, so that all systems, processes, and policies operate with the best interests of the child at their heart.
- The governing body are aware of their obligations under the Human Rights Act 1998, the Equality Act 2010, (including the Public Sector Equality Duty), and the local multi-agency safeguarding arrangements set out by the Kent Safeguarding Children Multi-Agency Partnership ([KSCMP](#)).
 - This includes but is not limited to safeguarding all members of the school community (for example, staff, learners, parents/carers and other family members) identified with protected characteristics within the Equality Act; age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, sexual orientation.
 - For further information about our approaches to equality, diversity, and inclusion, please access our schools website.
- The governing body and leadership team will ensure that there are policies and procedures in place to ensure appropriate action is taken in a timely manner to safeguard and promote children's welfare.
- The Headteacher will ensure that our child protection and safeguarding policies and procedures adopted by the governing body, are understood, and followed by all staff.
- The school has a nominated governor (**Victoria Acors**) for safeguarding. The nominated governor will support the DSL and have oversight in ensuring that the school has an effective policy which interlinks with other related policies, that locally agreed procedures are in place and being followed, and that the policies are reviewed at least annually and when required.
- The governing body will ensure an appropriate senior member of staff, from the school leadership team, is appointed to the role of designated safeguarding lead. The governing body and leadership team will ensure that the DSL is supported in their role and is provided with sufficient time so they can provide appropriate support to staff and children regarding any safeguarding and welfare concerns.

2.2 Designated Safeguarding Lead (DSL)

- The school has appointed **Joshua Payne – (Assistant Headteacher- Safeguarding and Wellbeing)**, a member of the senior leadership team, to act as our Designated Safeguarding Lead (DSL).

- The DSL has overall responsibility for the day-to-day oversight of safeguarding and child protection systems (including online safety and understanding the filtering and monitoring systems and processes in place) in school.
- The school has also appointed Deputy DSLs who will have delegated responsibilities and act in the DSLs absence.

- Whilst the activities of the DSL may be delegated to the deputies, the ultimate lead responsibility for safeguarding and child protection remains with the DSL and this responsibility will not be delegated.
- The DSL (and any deputies) will be more likely to have a complete safeguarding picture and will be the most appropriate person to advise staff on the response to any safeguarding concerns.
- It is the role of the DSL to carry out their functions as identified in Annex C of KCSIE. This includes but is not limited to:
 - Acting as the central contact point for all staff to discuss any safeguarding concerns
 - Maintaining a confidential recording system for safeguarding and child protection concerns
 - Coordinating safeguarding action for individual children
 - When supporting children with a social worker or looked after children the DSL should have the details of the child's social worker and the name of the virtual school head in the authority that looks after the child (with the DSL liaising closely with the designated teacher)
 - Liaising with other agencies and professionals in line with KCSIE and WTSC
 - Ensuring that locally established procedures as put in place by the three safeguarding partners as part of the [Kent Safeguarding Children Multi-Agency Partnership](#) (KSCMP) procedures, including referrals, are followed, as necessary.
 - Representing, or ensure the school is appropriately represented at multi-agency safeguarding meetings (including child protection conferences)
 - Managing and monitoring the school role in any multi-agency plan for a child.
 - Being available during term time (during school hours) for staff in the school to discuss any safeguarding concerns.
 - Ensuring adequate and appropriate DSL cover arrangements in response to any closures and any out of hours and/or out of term activities.
 - Taking lead responsibility for online safety, including understanding the filtering and monitoring systems and processes in place.

- Helping promote educational outcomes by sharing the information about the welfare, safeguarding and child protection issues that children, including children with a social worker, are experiencing, or have experienced, with teachers and school leadership staff.
 - Ensuring adequate and appropriate DSL cover arrangements in response to any closures and out of hours and/or out of term activities.
 - Ensuring all staff access appropriate safeguarding training and relevant updates in line with the recommendations within KCSIE.
 - Informing the Headteacher of any significant safeguarding issues.
 - Liaising with the Headteacher to inform them of any safeguarding issues, especially ongoing enquiries under section 47 of the Children Act 1989 and police investigations. This includes being aware of the requirement for children to have an Appropriate Adult ([PACE Code C 2019](#)).
- The DSL will undergo appropriate and specific training to provide them with the knowledge and skills required to carry out their role. Deputy DSLs will be trained to the same standard as the DSL. The DSLs training will be updated formally at least every two years, but their knowledge and skills will be updated through a variety of methods at regular intervals and at least annually.

2.3 Members of Staff

- Our staff play a particularly important role in safeguarding as they are in a position to observe any changes in a child's behaviour or appearance, identify concerns early, provide help for children, promote children's welfare and prevent concerns from escalating.
- All members of staff have a responsibility to:
 - Provide a safe environment in which children can learn.
 - Be alert to any issues of concern in a child's life at home or elsewhere.
 - Be aware of the indicators of abuse, neglect and exploitation so that they can identify cases of children who may need help or protection.
 - Know what to do if a child tells them that they are being abused, neglected, or exploited and understand the impact this can have upon a child.
 - Be able to identify and act upon indicators that children are, or at risk of developing mental health issues.
 - Be prepared to identify children who may benefit from early help and understand the early help process and their role in it.
 - Understand the school safeguarding policies and systems.
 - Undertake and engage in regular and appropriate training which is regularly updated.
 - Be aware of the local process of making referrals to children's social care and statutory assessment under the Children Act 1989.
 - Know how to maintain an appropriate level of confidentiality.
 - Reassure children who report concerns that they are being taken seriously and that they will be supported and kept safe.
 - Act in line with our Staff Handbook and Code of Conduct.

- Act in line with Teachers' Standards 2012 which state that teachers (including Headteachers) should safeguard children's wellbeing and maintain public trust in the teaching profession as part of their professional duties.
 - Reinforce the importance of online safety to parents.
 - Teach preventative safeguarding education to learners within our school on key issues including, but not limited to online safety, child on child abuse, bullying, healthy relationships, and people who help us.
- Staff at Laleham Gap School recognise that children may not feel ready or know how to tell someone that they are being abused, exploited, or neglected, and/or they may not recognise their experiences as being abusive or harmful. This should not prevent staff from having professional curiosity and speaking to a DSL if they have any concerns about a child.
- Staff at Laleham Gap School will determine how best to build trusted relationships with children, young people and parents/carers which facilitate appropriate professional communication in line with existing and relevant policies, for example, our **Code of Conduct** and **Positive Behaviour and Relationships Support policy**.

2.4 Children and Young People

- Children and young people (learners) have a right to:
 - Feel safe, be listened to, and have their wishes and feelings taken into account.
 - Confidently report abuse, neglect or exploitation, knowing their concerns will be treated seriously, and knowing they can safely express their views and give feedback.
 - Contribute to the development of school safeguarding policies.
 - Receive help from a trusted adult.
 - Learn how to keep themselves safe, including online.

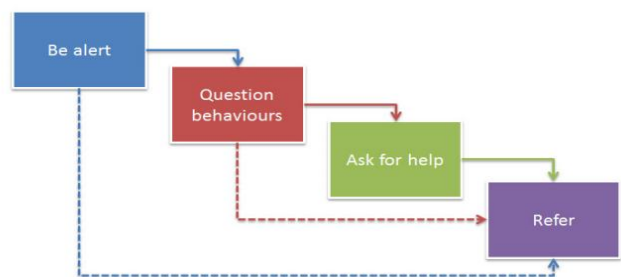
2.5 Parents and Carers

- Parents/carers have a responsibility to:
 - Understand and adhere to the relevant school policies and procedures.
 - Talk to their children about safeguarding issues with their children and support the school in their safeguarding approaches.
 - Identify behaviours which could indicate that their child is at risk of harm, including online.
 - Seek help and support from the school or other agencies.

3. Child Protection Procedures

3.1 Recognising Indicators of Abuse, Neglect and Exploitation

- Staff will maintain an attitude of 'it could happen here' where safeguarding is concerned. When concerned about the welfare of a child, staff will always act in the best interests of the child.
- All staff are made aware of the definitions and indicators of abuse, neglect and exploitation as identified by 'Working Together to Safeguard Children' and 'Keeping Children Safe in Education'. This is outlined locally within the [Kent Support Levels Guidance](#).
- Laleham Gap School recognise that when assessing whether a child may be suffering actual or potential harm there are four categories of abuse (for more in-depth information, see appendix 1):
 - Physical abuse
 - Sexual abuse
 - Emotional abuse
 - Neglect
- By understanding the indicators of abuse, neglect and exploitation, we can respond to problems as early as possible and provide the right support and services for the child and their family.
- All members of staff are expected to be aware of and follow the ['What to do if you are worried a child is being abused'](#) guidance if they are concerned about a child:



- Laleham Gap School recognises that concerns may arise in many different contexts and can vary greatly in terms of their nature and seriousness. The indicators of child abuse, neglect and exploitation can vary from child to child. Children develop and mature at different rates, so what appears to be worrying behaviour for a younger child might be normal for an older child. It is important to recognise that indicators of abuse, neglect and exploitation do not automatically mean a child is being harmed, however all concerns should be taken seriously and will be explored by the DSL on a case-by-case basis.
- Laleham Gap School recognises abuse, neglect, exploitation and safeguarding issues are rarely standalone events and cannot always be covered by one definition or one label alone. In many cases, multiple issues will overlap with one another, therefore staff will always be vigilant and always raise concerns with a DSL.

- Parental behaviours can indicate child abuse, neglect, or exploitation; staff will be alert to parent-child interactions or concerning parental behaviours; this could include parents who are under the influence of drugs or alcohol, or, if there is a sudden change in their mental health.
- Children may report abuse, neglect or exploitation happening to themselves, their peers or their family members. All reports made by children to staff will be taken seriously and will be responded to in line with this policy.
- Safeguarding incidents and/or behaviours can be associated with factors and risks outside of the school. Children can be at risk of abuse, neglect or exploitation in situations outside their families; extra-familial harms take a variety of different forms and children can be vulnerable to multiple harms including (but not limited to) sexual exploitation, criminal exploitation, sexual abuse, serious youth violence and county lines.
- Laleham Gap School recognises that technology can be a significant component in many safeguarding and wellbeing issues; children are at risk of abuse or exploitation online from people they know (including other children) and from people they do not know; in many cases, abuse will take place concurrently via online channels and in daily life.
- Laleham Gap School recognises that some children have additional or complex needs and may require access to intensive or specialist services to support them.
- Following a concern about a child's safety or welfare, the searching and screening of children and confiscation of any items, including any electronic devices, will be managed in line with the school's 'Searching and Confiscation' policy (which is informed by the DfE [Searching, screening and confiscation at school](#) guidance).
 - The DSL (or deputy) will be informed of any searching incidents where there were reasonable grounds to suspect a learner was in possession of a prohibited item as listed in our positive behaviour policy. The DSL (or deputy) will then consider the circumstances of the learner who has been searched to assess the incident against any potential wider safeguarding concerns.
 - The Headteacher or the most Senior member of staff on site, must be consulted about all searches, unless imminent danger is suspected.
 - **Staff will involve the DSL (or deputy) without delay** if they believe that a search has revealed a safeguarding risk.

3.2 Responding to Child Protection Concerns

- If staff are made aware of a child protection concern, they are expected to:
 - listen carefully to child, reflecting back the concern.
 - use the child's language.
 - be non-judgmental.

- avoid leading questions; only prompting the child where necessary with open questions to clarify information where necessary. For example who, what, where, when or Tell, Explain, Describe (TED).
 - not promise confidentiality as concerns will have to be shared further, for example, with the DSL and potentially Integrated Children's Services.
 - be clear about boundaries and how the report will be progressed.
 - record the concern on CPOMS using the facts as the child presents them.
 - inform the DSL (or deputy), as soon as practically possible.
- If staff have any concerns about a child's welfare, they are expected to act on them immediately. If staff are unsure if something is a safeguarding issue, they will speak to the DSL (or deputy).
- The DSL or a deputy should always be available to discuss safeguarding concerns. If in exceptional circumstances, a DSL is not available, this should not delay appropriate action being taken by staff. Staff should speak to a member of the senior leadership team, take advice from the Education Safeguarding Service or a consultation with a social worker from the Front Door (for contact information, see flowchart on page 4). In these circumstances, any action taken will be shared with a DSL as soon as is possible.
- All staff are made aware that early information sharing is vital for the effective identification, assessment, and allocation of appropriate service provision, whether this is when problems first emerge, or where a child is already known to other agencies. Staff will not assume a colleague, or another professional will act and share information that might be critical in keeping children safe.
- Laleham Gap School will respond to concerns in line with the Kent Safeguarding Children Multi-Agency Partnership procedures (KSCMP).
 - The full KSCMP procedures and additional guidance relating to reporting concerns and specific safeguarding issues can be found on their website: www.kscmp.org.uk
- In Kent, Early Help and Preventative Services and Children's Social Work Services are part of [Integrated Children's Services](#) (ICS) and are accessed via the '[Front Door Service](#)'/[Kent Children's Services Portal](#).
- 'Early help' is defined in 'Working together to safeguard children' as support for children of all ages that improves a family's resilience and outcomes or reduces the chance of a problem getting worse. It is not an individual service, but a system of support delivered by local authorities and their partners, including education providers, working together and taking collective responsibility to provide the right provision in their area.
 - If early help support is appropriate, the DSL (or a deputy) will lead on exploring internal resources available and liaising with other universal or additional services available via local agencies.
 - Where Intensive Support Early Help (provided by ICS, outlined in the [KSCMP support levels guidance](#)) is considered to be appropriate, the DSL (or deputy) will make a 'request for support' via the [Kent Children's Services Portal](#).

- Staff, including the DSL, may be required to work with other agencies and professionals in an early help assessment.
 - The DSL will keep all Early Help cases under constant review and consideration will be given to escalating concerns and/or seeking advice from the Front Door Service if the situation does not appear to be improving or is getting worse.
- Where a child is suffering, or is likely to suffer from harm, or is in immediate danger (for example, under section 17 or 47 of the Children Act), intensive or specialist support is required and a 'request for support' will be made immediately to Kent [Integrated Children's Services](#) (via the [portal](#)) and/or the police, [Kent Support Level Guidance and KSCMP procedures](#).
 - Laleham Gap School recognise that in situations where there are immediate child protection concerns for a child as identified in line with Support Level Guidance, **it is NOT to investigate as a single agency**, but to act in line with KSCMP guidance which may **involve multi-agency decision making**.
 - If they believe a child may be in need of support but are unclear whether a '[Request for Support](#)' should be submitted, the DSL may seek [advice or guidance](#) from a social worker via the Front Door Service before deciding next steps.
- The DSL, or a deputy DSL in the absence of the DSL will have the overall responsibility for making referrals. However, all staff are made aware of the local process for making referrals to Integrated Children's Services and for statutory assessments under the Children Act 1989, especially section 17 (children in need) and section 47 (a child suffering, or likely to suffer, significant harm) that may follow a referral, along with the role they might be expected to play in such assessments.
- If staff have any concerns about a child's welfare, they are expected to act on them immediately. If staff are unsure if something is a safeguarding issue, they will speak to the DSL (or deputy). If in exceptional circumstances, a DSL is not available, this should not delay appropriate action being taken by staff.
 - Staff will speak to a member of the Laleham Gap School senior leadership team, request a consultation with a social worker from the Front Door Service, or make a request for support to the Front Door Service themselves.
 - In these circumstances, any action taken by staff will be shared with a DSL as soon as is possible.
- In the event of a request for support to the Front Door Service being necessary, parents/carers will be informed and consent to this will be sought by the DSL in line with guidance provided by KSCMP and ICS. Parents/carers will always be informed in the case of a request for support being submitted by the school, unless there is a valid reason not to do so, for example, if informing them may put a child at risk of harm or could undermine a criminal investigation.
- If, after a request for support or any other planned external intervention, a child's situation does not appear to be improving, or concerns regarding receiving a decision or the decisions made, staff or the DSL will re-refer (if appropriate) and/or DSLs will follow the [Kent Escalation and Professional](#)

[Challenge Policy](#) to ensure their concerns have been addressed and, most importantly, that the child's situation improves.

- DSLs and staff will be mindful of the need for the school to ensure any activity or support implemented to support children and/or families is recorded. Support provided by the school where families are struggling will be overseen and reviewed by the DSL on a regular basis to ensure activity does not obscure potential safeguarding concerns from the wider professional network.

3.3 Child Protection Records

- All safeguarding concerns, discussions and decisions, and reasons for those decisions, will be recorded in writing on the [school safeguarding system CPOMS](#) and passed without delay to the DSL. Our records will include a clear and comprehensive summary of any concerns, details of how concerns were followed up and resolved, and a note of any action taken, decisions reached and outcomes
- The system for recording incidents and concerns can be accessed at:

- Records will be completed as soon as possible after the incident/event, using the child's words and **will be completed electronically by any member of staff supporting the child**. Child protection records will record **facts and not personal opinions**. A body map will be completed on CPOMS if visible injuries to a child have been observed.
- If there is **an immediate safeguarding concern** the member of staff will **consult with a DSL before completing the form as reporting urgent concerns takes priority**.
- If members of staff are in any doubt about recording requirements, they will discuss their concerns with the DSL.
- Our child protection records will include a clear and comprehensive summary of any concerns, details of concerns which were followed up and resolved, any note of action taken or not taken, how any decisions reached and any outcomes.
- Child protection records are kept confidential and stored securely. Child protection records will be kept for individual children and will be maintained separately from all other records relating to the child in the school. Child protection records are kept in accordance with data protection legislation and are retained centrally and securely by the DSL.

3.4 Transferring Child Protection Files

- All child protection records will be transferred in accordance with data protection legislation to the child's subsequent school or college, under confidential and separate cover as soon as possible; within 5 days for an in-year transfer or within the first 5 days of the start of a new term. Child Protection files

will be transferred securely to the new DSL, separately to the child's main file, and a confirmation of receipt will be obtained.

- In addition to the child protection file, the DSL will also consider if it would be appropriate to share any information with the DSL at the new school or college in advance of a child leaving, for example, information that would allow the new school or college to continue to provide support.
- Where the school receives child protection files from another setting, the DSL will ensure key staff will be made aware of relevant information as required.
- Where a learner joins the school and no child protection files are received, the DSL will proactively seek to confirm from the previous setting whether any child protections exist for the learner, and if so, if the files have been sent.

3.5 Multi-Agency Working

- Laleham Gap School recognises the pivotal role we have to play in multi-agency safeguarding arrangements and is committed to its responsibility to work within the [KSCMP](#) multi-agency safeguarding arrangements as identified within 'Working Together to Safeguard Children'.
- The School leadership team, governing body and DSL will work to establish strong and co-operative local relationships with professionals in other agencies, including the safeguarding partners in line with local and national guidance. Some examples of multi-agency relationships may include, social workers, early help workers, health professionals (such as paediatricians, health visitors, mental health services and speech and language therapists), specialist teachers, education psychologists, other schools/settings where children attend more than one setting/provision and police.
- Laleham Gap School recognises the importance of multi-agency working and is committed to working alongside partner agencies to provide a coordinated response to promote children's welfare and protect them from harm. This includes contributing to [KSCMP](#) processes as required, such as, participation in relevant safeguarding multi-agency plans and meetings, including Child Protection Conferences, Core Groups, Strategy Meetings, Child in Need meetings or other early help multi-agency meetings.
- The Lead DSL and where appropriate, Deputy DSLs, are encouraged to undertake additional training provided by KSCMP, support with the delivery of this, and understand the [KCSMP Escalation Procedures](#).
- The School will allow access for Kent Children's Social Work Service and, where appropriate, from a placing local authority, to conduct, or to consider whether to conduct, a section 17 or a section 47 assessment.
- The Headteacher and DSL are aware of the requirement for children to have an Appropriate Adult ([PACE Code C 2019](#)) where there is a need for detention, treatment and questioning by police officers

and will respond to concerns in line with our school 'Searching and Confiscation' policy and Positive Behaviour Policy which is informed by the DfE ['Searching, screening and confiscation at school'](#) guidance.

3.6 Confidentiality and Information Sharing

- Laleham Gap School recognises our duty and powers to hold, use and share relevant information with appropriate agencies in matters relating to child protection at the earliest opportunity, as per statutory guidance outlined within Keeping Children Safe in Education (KCSIE) and Working Together to Safeguard Children (WTSC). **The UK GDPR and Data Protection Act 2018 do not prevent schools from sharing information responsibly where doing so may help keep a child safe.**
- Laleham Gap School has an appropriately trained Data Protection Officer (DPO) to ensure compliance with all matters relating to confidentiality and information sharing.

- All staff are made aware of the need to protect the privacy of the children in their care, as well the legal requirements that exist to ensure that information relating to the child is handled in a way that ensures both confidentiality and safeguarding.
- Where reasonably possible, the school will hold more than one emergency contact number for each child. There is an expectation that emergency contact information will be held for both parents, unless doing so would put a child at risk of harm. This supports our safeguarding responsibilities and ensures we can act swiftly in emergencies.
- Staff will have due regard to the relevant data protection principles, which allow them to share and withhold personal information when necessary to safeguard children.
 - The Data Protection Act 2018 and the UK General Data Protection Regulation (UK GDPR) place duties on schools and individuals to process personal information fairly and lawfully, and to keep the information they hold safe and secure. **The Data Protection Act 2018 and UK GDPR do not prevent the sharing of information for the purposes of keeping children safe. Fears about sharing information must not stand in the way of safeguarding and promoting the welfare of children.**
 - All staff will be provided with training and information to ensure they have due regard to the relevant data protection principles, which allow them to share and/or withhold personal information. This training will be provided regularly via The National College platform and face-to-face in Professional Development Meetings.

- KCSIE, the [Information Commissioner's Office](#) (ICO) and the DfE "[Information sharing advice for safeguarding practitioners](#)" guidance provides further details regarding information sharing principles and expectations.
- The Headteacher and DSL will disclose relevant safeguarding information about a learner with staff on a 'need to know' basis. **See '3.7 – A Child's Right to Privacy' for further information.**
- All members of staff must be aware that while they have duties to keep information confidential, they also have a professional responsibility to share information proactively. This includes early identification, assessment, and response to risks or concerns about children's safety and welfare. This includes sharing information with the DSL and outside agencies as appropriate.
- All members of staff must be aware that they have duties to keep information confidential, in line with, but not limited to:
 - LGS02 GDPR
 - LGS08 Staff Acceptable Use Policy
 - LGS09 Code of Conduct
- In regard to confidentiality and information sharing staff will only involve those who need to be involved, such as the DSL (or a deputy) and Kent Integrated Children's Services. **All staff are aware they cannot promise a child that they will not tell anyone about a report of any form of abuse, as this may not be in the best interests of the child.**

3.7 A Child's Right to Privacy

- Laleham Gap School recognises that children have a legal right to privacy under **Article 16 of the United Nations Convention on the Rights of the Child (UNCRC)**, which affirms their entitlement to a private family life, personal space, and protection of personal communications.
- **While safeguarding concerns may necessitate the sharing of information, this must be done proportionately and only when it is in the child's best interests.**
- Staff may request updates about a child if they are concerned or have made an initial report about a safeguarding incident, but the **Headteacher and DSL are responsible for determining what information is safe, lawful, and appropriate to share.** Sharing personal data that does not support a child's wellbeing or safety may infringe upon their rights. This should be considered carefully when an individual or groups of staff may not be in a position to support the child or family in question.
- Staff are reminded in annual training that they can escalate their concerns to the Headteacher, or, appropriate governors such as the Chair of Governors and Safeguarding Governor if they remain concerned. Where they are still not satisfied, outside charities and agencies such as the NSPCC and

Children's Integrated Services should be contacted for advice and support. See 'Section 3.8 – Complaints' for contact details and further information about this.

3.8 Complaints

- All members of the school community should feel able to raise or report any concerns about children's safety or potential failures in the school safeguarding regime. The school has a complaints procedure available to parents, learners and members of staff and visitors who wish to report concerns or complaints. This can be found on the staff shared area under policies, in the wellbeing office and the school's website. **Visitors are given information on arrival at the school of how to raise a safeguarding concern with the DSL. The DSL's contact number is also provided on the visitor lanyards.**
- Whilst we encourage members of our community to report concerns and complaints directly to us, we recognise this may not always be possible. Children, young people, and adults who have experienced abuse at school can contact the **NSPCC 'Report Abuse in Education' helpline** on **0800 136 663** or via email: help@nspcc.org.uk
- Staff can also access the **NSPCC whistleblowing helpline** if they do not feel able to raise concerns regarding child protection failures internally.
 - Staff can call **0800 028 0285** (8:00 AM to 8:00 PM Monday to Friday) or email help@nspcc.org.uk
- The leadership team at Laleham Gap School will take all concerns reported to the school seriously and all complaints will be considered and responded to in line with the relevant and appropriate process.
 - Anything that constitutes an allegation against a member of staff or volunteer will be dealt with in line with Section 8 of this policy.
- The complaints policy details the procedures for raising concerns and complaints with the Governing Body. Complaints against school staff (except the Headteacher) should be made in the first instance, to Mr Les Milton via the school office. Please mark them as Private and Confidential.
- Complaints that involve or are about the Headteacher should be addressed the Chair of Governors, Daniel Chantler, via the school office. Please mark them as Private and Confidential.
- Complaints about the Chair of Governors, any individual governor or the whole governing body should be addressed to Mrs Val Woodin (the Clerk to the Governing Body) via the school office. Please mark them as Private and Confidential.

4. Specific Safeguarding Issues

- Laleham Gap School is aware of the range of specific safeguarding issues and situations that can put children at greater risk of harm. In addition to Part One, DSLs, school leaders and staff who work directly with children will read Annex B of KCSIE which contains important additional information about specific forms of abuse and safeguarding issues.
- Where staff are unsure how to respond to specific safeguarding issues, they should follow the processes as identified in part 3 of this policy and speak with the DSL or a deputy.

4.1 Child on Child Abuse

- All members of staff at Laleham Gap School recognise that **children can abuse other children**; this is known as **child-on-child abuse** and that it can happen both inside and outside of school and online.
- Laleham Gap School recognises that child-on-child abuse can take many forms, including but not limited to:
 - Bullying, including cyberbullying, prejudice-based and discriminatory bullying
 - abuse in intimate personal relationships between children
 - physical abuse which can include hitting, kicking, shaking, biting, hair pulling, or otherwise causing physical harm
 - sexual violence and sexual harassment
 - consensual and non-consensual sharing of nudes and semi-nude images and/or videos (also known as sexting or youth produced sexual imagery)
 - causing someone to engage in sexual activity without consent, such as forcing someone to strip, touch themselves sexually, or to engage in sexual activity with a third party
 - upskirting (which is a criminal offence), which typically involves taking a picture under a person's clothing without their permission, with the intention of viewing their genitals or buttocks to obtain sexual gratification, or cause the victim humiliation, distress or alarm
 - initiation/hazing type violence and rituals
- Any allegations of child-on-child abuse will be recorded, investigated, and dealt with in line with this child protection policy and [KCSIE](#) (in particular, part two and five).
- Laleham Gap School adopts a zero-tolerance approach to child-on-child abuse. We believe that abuse is abuse and it will never be tolerated or dismissed as “just banter”, “just having a laugh”, “part of growing up” or “boys being boys”; this can lead to a culture of unacceptable behaviours and can create an unsafe environment for children and a culture that normalises abuse, which can prevent children from coming forward to report it.
- **All staff have a role to play in challenging inappropriate behaviours between children.** Staff recognise that some child-on-child abuse issues may be affected by gender, age, ability and culture of those involved. For example, for gender-based abuse, girls are more likely to be victims and boys more likely to be perpetrators.

- Laleham Gap School recognises that even if there are no reported cases of child-on-child abuse, such abuse is still likely to be taking place and it may be the case that it is just not being reported. As such, it is important that staff speak to the DSL (or deputy) about any concerns regarding child-on-child abuse.
- Laleham Gap School want children to feel able to confidently report abuse and know their concerns will be treated seriously. All allegations of child-on-child abuse will be reported to the DSL and will be recorded, investigated, and dealt with in line with associated school policies, including child protection, anti-bullying, and positive behaviour. Learners who experience abuse will be offered appropriate support, regardless of where the abuse takes place.
- Concerns about learners' behaviour, including child-on-child abuse taking place offsite will be responded to as part of a partnership approach with learners and parents/carers. Offsite behaviour concerns will be recorded and responded to in line with existing appropriate policies, for example anti-bullying, acceptable use, behaviour and child protection policies.
- Alleged victims, alleged perpetrators and any other child affected by child-on-child abuse will be supported by the school taking reports seriously, listening carefully, avoiding victim blaming, providing appropriate personalised wellbeing support, working with parents/carers, reviewing educational approaches, following procedures as identified in other policies e.g. the school anti-bullying, positive behaviour and child protection policy, and where necessary and appropriate, informing the police and/or Integrated Childrens Services.

4.1.a Prevention and Response to Child on Child Abuse

- To minimise the risk of child-on-child abuse, Laleham Gap School implements a comprehensive and proactive approach that aligns with statutory guidance and the principles of the United Nations Convention on the Rights of the Child (UNCRC).

Our measures include, but are not limited to:

- A robust **Anti-Bullying Policy** that is regularly reviewed and embedded across the school culture.
- Delivery of an **age- and ability-appropriate PSHE and RSE curriculum**, designed to educate children on respectful relationships, personal boundaries, and how to keep themselves and others safe.
- Provision of **high levels of individual support** for learners who may be vulnerable or require additional guidance.
- **Partnership working** with parents, carers, and external professionals to ensure a coordinated and informed response to concerns. This includes training and events delivered to staff, children

and parents by key partners and agencies such as CEOP, KCSMP, Kent Police, Prevent Education Officers and reputable organisations such as the Breck Bednar Foundation.

- A range of **accessible opportunities for children to express concerns or worries**, including trusted adults, anonymous reporting tools (such as our online safety portal), and regular wellbeing check-ins.
- Embedding **a restorative and safe culture that promotes accountability, empathy, and resolution.**
- **Promotion of the UNCRC, particularly Articles 19 and 29**, which affirm every child's right to be protected from harm and to learn in a safe environment
- **High levels of supervision across the school day**, including during transitions, break times, and online activities.
- **Provision of training and informative materials to parents and carers**, delivered via our **National College portal**, and supported by our **Designated Safeguarding Lead (DSL)** and **CEOP Ambassador**.
- **Social and emotional interventions to help children understand one-another, build resilience and develop a confident and assertive approach to speaking up.**
- **Regular school council meetings to share and voice any concerns**, including child on child and behaviour incidents, strengthening the voice of all children across the school through peer support.

4.2 Sexual Violence and Sexual Harassment

- When responding to concerns relating to child-on-child sexual violence or harassment, Laleham Gap School will follow the guidance outlined in Part five of [KCSIE](#).
- Laleham Gap school recognises that sexual violence and sexual abuse can happen anywhere, and all staff will maintain an attitude of 'it could happen here.' Laleham Gap School recognises sexual violence and sexual harassment can occur between two children of any age and sex. It can occur through a group of children sexually assaulting or sexually harassing a single child or group of children and can occur online and face to face (both physically and verbally). Sexual violence and sexual harassment is never acceptable.
- All victims of sexual violence or sexual harassment will be reassured that they are being taken seriously, regardless of how long it has taken them to come forward, and that they will be supported and kept safe. A victim will never be given the impression that they are creating a problem by reporting sexual violence or sexual harassment, or ever be made to feel ashamed for making a report.

- Abuse that occurs online or outside of the school will not be dismissed or downplayed and will be treated equally seriously and in line with relevant policies, for example anti-bullying, positive behaviour, child protection and online safety.
- Laleham Gap School recognises that the law is in place to **protect children and young people rather than criminalise them**, and this will be explained in such a way to learners that avoids alarming or distressing them.
- Laleham Gap School recognises that an initial disclosure to a trusted adult may only be the first incident reported, rather than representative of a singular incident and that trauma can impact memory, so children may not be able to recall all details or timeline of abuse. All staff will be aware certain children may face additional barriers to telling someone, for example because of their vulnerability, disability, sex, ethnicity, and/or sexual orientation. **As a special school for children with communication and interaction difficulties, it is vital that all staff recognise our learners may not be able to communicate their experiences effectively. Some learners may not be able to communicate this at all, instead their trauma may be present in other ways such as through changes to behaviour, engagement and levels of achievement.**
- The DSL (or deputy) is likely to have a complete safeguarding picture and will be the most appropriate person to advise on the initial response.
 - The DSL will make an immediate risk and needs assessment which will be considered on a case-by-case basis which explores how best to support and protect the victim and the alleged perpetrator, and any other children involved/impacted, in line with part five of KCSIE and relevant local/national guidance and support, for example [KSCMP](#) procedures.
 - The risk and needs assessment will be recorded and kept under review and will consider the victim (especially their protection and support), the alleged perpetrator, and all other children and staff and any actions that are required to protect them.
 - Any concerns involving an online element will take place in accordance with relevant local/national guidance and advice.
- Reports will initially be managed internally by the school and where necessary will be referred to [Integrated Children's Services](#) (Early Help and/or Children's Social Work Service) and/or the police. Important considerations which may influence this decision include:
 - the wishes of the victim in terms of how they want to proceed.
 - the nature of the alleged incident(s), including whether a crime may have been committed and/or whether Harmful Sexual Behaviour has been displayed.
 - the ages of the children involved.
 - the developmental stages of the children involved.
 - any power imbalance between the children.

- if the alleged incident is a one-off or a sustained pattern of abuse - sexual abuse can be accompanied by other forms of abuse and a sustained pattern may not just be of a sexual nature.
 - that sexual violence and sexual harassment can take place within intimate personal relationships between children.
 - understanding intra familial harms and any necessary support for siblings following incidents.
 - whether there are any ongoing risks to the victim, other children, adult students, or school staff.
 - any other related issues and wider context, including any links to child sexual exploitation and child criminal exploitation.
- The school will in most instances engage with both the victim's and alleged perpetrator's parents/carers when there has been a report of sexual violence; this might not be necessary or proportionate in the case of sexual harassment and will depend on a case-by-case basis. The exception to this is if there is a reason to believe informing a parent/carer will put a child at additional risk. Any information shared with parents/carers will be in line with information sharing expectations, our following policies: LGS02 GDPR, LGS08 Staff Acceptable Use and LGS09 Code of Conduct. Any data protection requirements, and where they are involved, will be subject to discussion with other agencies (for example Children's Social Work Service and/or the police) to ensure a consistent approach is taken.
 - If at any stage the DSL is unsure if a request for support is appropriate, advice may be sought from the Front Door Service.

4.3 Nude and/or Semi-Nude Image Sharing by Children

- Laleham Gap School recognises that consensual and non-consensual sharing of nudes and semi-nude images and/or videos (also known as youth produced/involved sexual imagery or "sexting") can be a safeguarding issue; all concerns will be reported to and dealt with by the DSL (or deputy).
- When made aware of concerns involving consensual and non-consensual sharing of nudes and semi-nude images and/or videos by children, staff are advised to:
 - Report any concerns to the DSL immediately.
 - Never view, copy, print, share, forward, store or save the imagery, or ask a child to share or download it – this may be illegal. If staff have already inadvertently viewed the imagery, this will be immediately reported to the DSL.
 - Not delete the imagery or ask the child to delete it.
 - Not say or do anything to blame or shame any children involved.
 - Explain to child(ren) involved that they will report the issue to the DSL and reassure them that they will receive appropriate support and help.
 - Not to investigate or ask the child or children involved in the incident to disclose information regarding the imagery.
 - Not share information about the incident with other members of staff, the child(ren) involved or their, or other, parents and/or carers. This is the responsibility of the DSL.

- Not promise confidentiality, as other agencies may need to be informed and be involved.
- DSLs will respond to concerns in line with non-statutory UKCIS guidance: [Sharing nudes and semi-nudes: advice for education settings working with children and young people](#) and the local [KSCMP](#) guidance. When made aware of a concern involving consensual and non-consensual sharing of nudes and semi-nude images and/or videos:
 - the DSL will hold an initial review meeting to explore the context and ensure appropriate and proportionate safeguarding action is taken in the best interests of any child involved. This may mean speaking with relevant staff and the children involved as appropriate.
 - parents and carers will be informed at an early stage and be involved in the process to best support children, unless there is good reason to believe that involving them would put a child at risk of harm.
 - All decisions and action taken will be recorded in line with our child protection procedures.
 - A referral will be made to Integrated Childrens Services via the Front Door Portal and/or the police immediately if:
 - the incident involves an adult (over 18).
 - there is reason to believe that a child has been coerced, blackmailed, or groomed, or there are concerns about their capacity to consent, for example, age of the child or they have special educational needs.
 - the image/videos involve sexual acts and a child under the age of 13, depict sexual acts which are unusual for the child's developmental stage, or are violent.
 - a child is at immediate risk of harm owing to the sharing of nudes and semi-nudes.
 - The DSL may choose to involve other agencies at any time if further information/concerns are disclosed at a later date.
 - If DSLs are unsure if a request for support is appropriate, advice may be sought from the Front Door Service.

4.4 Child Sexual Exploitation (CSE) and Child Criminal Exploitation (CCE)

- Laleham Gap School recognises that both CSE and CCE are forms of abuse that occur where an individual or group takes advantage of an imbalance in power to coerce, manipulate or deceive a child into taking part in sexual or criminal activity, in exchange for something the victim needs or wants, and/or for the financial advantage or increased status of the perpetrator or facilitator and/or through violence or the threat of violence. CSE and CCE can affect children, both male and female and can include children who have been moved (commonly referred to as trafficking) for the purpose of exploitation.

- Laleham Gap School recognises that children can become trapped in CCE as perpetrators can threaten victims and their families with violence or entrap and coerce them into debt. Children involved in criminal exploitation often commit crimes themselves which can mean their vulnerability as victims is not always recognised (particularly older children) and they are not treated as victims, despite the harm they have experienced. The experience of girls who are criminally exploited can also be very different to that of boys. We also recognise that boys and girls being criminally exploited may be at higher risk of child sexual exploitation (CSE).
- Laleham Gap School recognises that CSE can occur over time or be a one-off occurrence and may happen without the child's immediate knowledge, for example through others sharing videos or images of them on social media. CSE can affect any child who has been coerced into engaging in sexual activities and includes 16 and 17 year olds who can legally consent to have sex. Some children may not realise they are being exploited, for example they may believe they are in a genuine romantic relationship.
- Staff at Laleham Gap School recognise that a wide range of CSE and CCE can be identified as serious forms of modern slavery and should be treated as such.
- If staff are concerned that a child may be at risk of CSE or CCE, immediate action should be taken by speaking to the DSL or a deputy.

4.5 Serious Violence

- All staff are made aware of the indicators which may signal children are at risk from or are involved with serious violent crime. These may include unexplained gifts or new possessions, increased absence from school, a change in friendships or relationships with older individuals or groups, a significant decline in performance, signs of self-harm or a significant change in wellbeing, or signs of assault or unexplained injuries. Unexplained gifts or new possessions could also indicate that children have been approached by, or are involved with, individuals associated with criminal networks or gangs and may be at risk of CCE.
- Laleham Gap School recognises that the likelihood of involvement in serious violence may be increased by factors such as being male, having been frequently absent or permanently excluded, having experienced child maltreatment and having been involved in offending, such as theft or robbery. Additionally, violence can peak in the hours just before or just after school, when learners are travelling to and from school and these may be particularly risky times for children involved in serious violence.
- Any concerns regarding serious violence will be reported and responded to in line with other child protection concerns by speaking with a DSL or deputy. The initial response to child victims is important and staff will take any allegations seriously and work in ways that support children and keep them safe.

4.6 Modern Slavery and the National Referral Mechanism (NRM)

- Modern slavery encompasses human trafficking and slavery, servitude and forced or compulsory labour. Exploitation can take many forms, including sexual exploitation, forced labour, slavery, servitude, forced criminality and the removal of organs. Further information on the signs that someone may be a victim of modern slavery, the support available to victims and how to refer them to the NRM is available in the Statutory Guidance: [Modern slavery: how to identify and support victims](#).
- If there are concerns that any member of the community is a victim or involved with modern slavery, concerns should be shared with a DSL or deputy and will be responded to in line with this policy.

4.7 So-called Honour Based Abuse (HBA)

- So-called 'honour'-based abuse (HBA) encompasses incidents or crimes which have been committed to protect or defend the honour of the family and/or the community, including female genital mutilation (FGM), forced marriage, and practices such as breast ironing. Abuse committed in the context of preserving 'honour' often involves a wider network of family or community pressure and can include multiple perpetrators.
- All forms of HBA are abuse, regardless of the motivation, and concerns will be responded to in line with section 3 of this policy. Staff will report any concerns about HBA to the DSL (or a deputy). If there is an immediate threat, the police will be contacted.
- All staff will speak to the DSL (or deputy) if they have any concerns about forced marriage. Staff can also contact the Forced Marriage Unit if they need advice or information: **020 7008 0151** or fmu@fco.gov.uk
- Whilst all staff will speak to the DSL (or deputy) if they have any concerns about FGM, there is a specific legal reporting duty on teachers.
 - Section 5B of the Female Genital Mutilation Act 2003 (as inserted by section 74 of the Serious Crime Act 2015) places a statutory duty upon teachers in England and Wales, to personally report to the police where they discover that FGM appears to have been carried out.
 - It will be rare for teachers to see visual evidence, and they should not be examining learners, however teachers who do not personally report such concerns may face disciplinary sanctions. Further information on when and how to make a report can be found at: [Mandatory reporting of female genital mutilation procedural information](#) and [FGM Mandatory reporting Duty Fact Sheet](#).

- Unless the teacher has good reason not to, they are expected to also discuss any FGM concerns with the DSL (or a deputy), and Kent Integrated Childrens Services should be informed as appropriate.

4.8 Preventing radicalisation

- Laleham Gap School recognises that children may be susceptible to radicalisation into terrorism.
- Laleham Gap School is aware of our duty under section 26 of the Counter-Terrorism and Security Act 2015 (the CTSA 2015), to have “due regard to the need to prevent people from being drawn into terrorism”, also known as the Prevent duty and the [specific obligations](#) placed upon us as an education provider regarding risk assessments, working in partnership, staff training, and IT policies.
- It is possible to protect people from extremist ideology and intervene to prevent those at risk of radicalisation being drawn to terrorism. As with other safeguarding risks, staff should be alert to changes in children's behaviour, which could indicate that they may be in need of help or protection.
- All staff have received appropriate training to enable them to be alert to changes in children's behaviour which could [indicate that they may need help or protection from radicalisation](#). School staff have been trained using DfE and The National College materials. We also access the Kent and Medway Prevent Education Officer for support and training as required. For new members of staff, Prevent training is covered in our 'Induction and Foundations' programme.
- Staff will be supported to use their judgement in identifying children who might be at risk of radicalisation and will act proportionately; staff will report concerns to the DSL (or a deputy), who, where appropriate, will follow the [local procedures](#) in regard to making a Prevent referral.
- If there is an **immediate threat to safety**, the **police will be contacted via 999**.
- Where a child is receiving support regarding concerns relating to preventing radicalisation, for example, through the 'Channel' programme, the DSL will consider if it would be appropriate to share any information if/when a child leaves to attend any new schools/colleges, so support can be put in place in place for when the child arrives. **Leaders and school staff can access statutory guidance on Channel: [Channel guidance](#) and [Channel training from the Home Office](#).**

4.9 Cybercrime

- Laleham Gap School recognises that children with particular skill and interest in computing and technology may inadvertently or deliberately stray into 'cyber-enabled' (crimes that can happen offline but are enabled at scale and at speed online) or 'cyber dependent' (crimes that can be committed only by using a computer/internet enabled device) cybercrime.

- If staff are concerned that a child may be at risk of becoming involved in cyber-dependent cybercrime, the DSL or a deputy will be informed, and consideration will be given to accessing local support and/or referring into the [Cyber Choices](#) programme, which aims to intervene when learners are at risk of committing, or being drawn into, low level cyber-dependent offences and divert them to a more positive use of their skills and interests.
- Where there are concerns about 'cyber-enabled' crime such as fraud, purchasing of illegal drugs online, child sexual abuse and exploitation, or other areas of concern such as online bullying or general online safety, they will be responded to in line with the child protection and other appropriate policies.
- DSLs will also decide when it is appropriate to seek advice and support from Kent Police and/or the Front Door Service.

4.10 Domestic abuse

- Laleham Gap School recognises that:
 - domestic abuse can encompass a wide range of behaviours and may be a single incident or a pattern of incidents.
 - domestic abuse can include, but is not limited to, psychological (including coercive control), physical, sexual, economic, or emotional abuse.
 - children can be victims of domestic abuse if they see, hear, or experience the effects of abuse at home and/or suffer domestic abuse in their own intimate relationships (teenage relationship abuse).
 - anyone can be a victim of domestic abuse, regardless of sexual identity, age, ethnicity, socio-economic status, sexuality or background, and domestic abuse can take place inside or outside of the home.
 - domestic abuse can take place within different types of relationships, including ex-partners and family members.
 - there is always a potential for domestic abuse to take place when parents/families separate, or for existing domestic abuse to persist or escalate post separation.
 - domestic abuse can have a detrimental and long-term impact on children's health, well-being, development, and ability to learn.
 - domestic abuse concerns will not be looked at in isolation and our response will be considered as part of a holistic approach which takes into account children's lived experiences.
 - it is important not to use victim blaming language and to adopt a trauma informed approach when responding to concerns relating to domestic abuse.
- If staff are concerned that a child may be at risk of seeing, hearing, or experiencing domestic abuse in their home or in their own intimate relationships, immediate action should be taken by speaking to the DSL or a deputy.
- Laleham Gap School is an [Operation Encompass School](#). This means we work in partnership with Kent Police to provide support to children experiencing the effects of domestic abuse. An Operation

Encompass notification is sent to the school when the police are called to an incident of domestic abuse and there are children in the household; the police are expected to inform schools before the child(ren) arrive the following day.

- Operation Encompass notifications help ensure that we have up to date and relevant information about children's circumstances and enable us to put immediate support in place according to the child's needs.
- Operation Encompass does not replace statutory safeguarding procedures and where appropriate, a referral to the Front Door Service will be made if there are any concerns about a child's welfare.
- Where the school is unsure of how to respond to a notification, advice will be sought from the **Front Door Service** or the **Operation Encompass helpline** which is available 8AM to 1PM, Monday to Friday on **0204 513 9990**.

4.11 Mental health

- All staff recognise that mental health problems can, in some cases, be an indicator that a child has suffered or is at risk of suffering abuse, neglect or exploitation.
- Staff are aware that children's experiences, for example where children have suffered abuse and neglect, or other potentially traumatic Adverse Childhood Experiences (ACEs), can impact on their mental health, behaviour, and education.
- Staff are well placed to observe children day-to-day and identify those whose behaviour suggests that they may be experiencing a mental health problem or be at risk of developing one.
- If staff have a mental health concern about a child that is also a safeguarding concern, immediate action should be taken by speaking to the DSL or a deputy.

4.12 Bruising in non-mobile children

- Laleham Gap supports children and families with a broad range of needs. Some of our children, or, their family members may include non-mobile children (meaning a child who is unable to move independently through rolling, crawling, cruising, or bottom shuffling).
- Bruising in babies, infants or children with complex needs that are not mobile is unusual and should always be explored. It is the responsibility of school staff to help protect any child we come into contact with, even if they do not attend our school. If we are aware the child in question attends another setting, the DSL or Headteacher will reach out to colleagues in those settings to raise concerns and share information as appropriate.

- If our School is concerned about actual or suspected bruising on a non-mobile child, we will respond in line with the [‘Kent and Medway Protocol for the Management of Actual or Suspected Bruising in Infants and Children who are not Independently Mobile’](#) procedures (2.2.8 of the KSCMP procedures). In summary, these procedures state:
 - If a child appears seriously ill or injured, emergency treatment should be sought through an emergency department (ED) and the Kent ICS should be notified of the concern and the child’s location.
 - In all other cases:
 - Staff must inform the DSL immediately and describe and document accurately on a body map, the size, shape, colour, and position of the mark/s on the head and/or body.
 - Any explanation of the history of the injury or comments by the parents/carers will be documented accurately (verbatim) in the child’s record, along with the body map.
 - If there is a concern about parental response to the injury, no explanation, or an explanation that is inadequate, unlikely or does not rule out abuse or neglect, an immediate referral will be made to Kent Integrated Childrens Services, who have responsibility for arranging further multi-agency assessments.
 - If there are concerns regarding the immediate safety of the child or staff, the police will be called.
 - If the setting is in any doubt as to how to respond to bruising on a non-mobile child, advice may be sought from the Front Door Service.

5. Supporting Children Potentially at Greater Risk of Harm

- Whilst **all** children should be protected, Laleham Gap School acknowledge that some groups of children are potentially at greater risk of harm. This can include the following groups:
 - Children with learning disabilities and difficulties.
 - Children with parents who have their own disabilities and difficulties, including Young Carers.
 - Members of the LGBT community or children exploring gender identity.
 - Girls with autism.
 - Looked After Children (Children in Care) and Previously Looked After Children.
 - Children from migrant families.
 - Children placed with Laleham Gap due to safeguarding concerns such as Section 47 Procedures.

5.1 Safeguarding Children with Special Educational Needs or Disabilities (SEND)

- Laleham Gap School acknowledges that children with special educational needs or disabilities (SEND) or certain health conditions can face additional safeguarding challenges and barriers for recognising

abuse, neglect and exploitation. Staff should be aware that by definition, any child in our specialist setting may be inherently more vulnerable.

- Laleham Gap School recognises that children with SEND may face additional communication barriers and experience difficulties in managing or reporting abuse or challenges. Children with SEND will be appropriately supported to communicate and ensure that their voice is heard and acted upon.
- All members of staff will be encouraged to appropriately explore possible indicators of abuse, neglect and exploitation such as behaviour, mood changes or injuries and not to assume that they are related to the child's special education needs or disability.
- Members of staff are encouraged to be aware that children with SEND, or certain medical conditions, can be disproportionately impacted by safeguarding concerns or behaviour, such as exploitation, peer group isolation or bullying including prejudice-based bullying, without outwardly showing any signs.
- To address these additional challenges, our school has implemented a broad range of wellbeing targeted and specialist support. The DSL will work closely with the Form Tutors, Wellbeing Staff, Therapists and other relevant staff to plan support as required.

5.2 Personal/Intimate Care

- Laleham Gap School follows Safer Working Practice guidance and acknowledges that young children and individuals with specific difficulties may require support with toileting and personal/intimate care. Guidance for staff supporting learners requiring personal/intimate care can be found in our '**Intimate Care Policy**', which ensures that the health, safety, independence, and welfare of children is promoted, and their dignity and privacy are respected.
- Arrangements for children requiring regular intimate will be agreed with parents in an open and transparent manner and accompanied by robust recording systems. These procedures will be agreed with the DSL or Deputy DSL. The Head of Therapies will also be consulted depending on the child's needs.
 - Any child requiring regular personal/intimate care to meet their needs in school will have this agreed as part of an individual care plan. Some children may have additional guidance in medical care plans, particularly where there is a physical need or toileting is affected by medicines or supplements such as Movicol.
 - Personal/intimate care plans name key staff and outline the procedures specific to the individual to ensure that the health, safety, independence, and welfare of children is promoted, and their dignity and privacy are respected.

5.3 Children Requiring Mental Health Support

- Laleham Gap School has an important role to play in supporting the mental health and wellbeing of our learners. Mental health problems can, in some cases, be an indicator that a child has suffered or is at risk of suffering abuse, neglect or exploitation.
- Where there are concerns regarding possible mental health problems for learners, staff should discuss their concern with the DSL, Deputy DSL. If there is serious concern for the learner's immediate safety, this should be reported immediately to the DSL or Deputy. The school provides a range of universal, targeted and specialist support interventions to support the mental health needs of learners, in addition to referral and liaison with external services as required. If members of staff are concerned about a child, they should refer them to the school's weekly Wellbeing Meeting via CPOMS, tagging the issues as 'Wellbeing Referrals and Discussions' and consult the Pastoral Policy.
- Laleham gap train staff across the school in Mental Health First Aid and Suicide Awareness. A list of these is available with the school office.
- Laleham Gap employ a range of therapeutic staff and Wellbeing Caseworkers to enhance our education and support key children. They are involved in weekly wellbeing meetings to assist with decision making and sign posting for children who may need additional mental health support, such as clinical services.
- Age/ability appropriate education is provided to our learners to help promote positive health, wellbeing, and resilience.
- Children who require specialist mental health assistance should be referred to Kent School Health, or, in more concerning situations CYPMHS (CAMHS) via the Single Point of Access. In cases where a child could be at risk of harm of their family would benefit from additional support due to mental health concerns, Children's Integrated Services will also be notified via the Front Door Portal.

5.4 Children Who Are Absent From Education

- Children being absent from education for prolonged periods and/or on repeat occasions can act as a vital warning sign to a range of safeguarding issues including neglect, child sexual and child criminal exploitation - particularly county lines.
- A robust response to children who are absent from education for prolonged periods and/or on repeat occasions will support the identification of such abuse and may help prevent the risk of children going missing in the future. This includes when problems are first emerging and also where children are already known to Kent Integrated Children's Services and/or have a social worker (such as a child who is a child in need or who has a child protection plan, or is a looked after child), where being absent from education may increase known safeguarding risks within the family or in the community. Laleham Gap holds weekly attendance meetings to identify and address these issues as early as possible.

- Where possible, the school will hold more than one emergency contact number for each learner, so we have additional options to make contact with a responsible adult if a child missing education is also identified as a welfare and/or safeguarding concern (see section 3.5).
- Where the school have concerns that a child has unexplainable and/or persistent absences from education and/or is missing from education, we will respond in line with our statutory duties (DfE: [Children missing education](#)) and local policies. Local support is available via the [Kent PRU and Attendance Service \(KPAS\)](#).

5.5 Children Who Are Absent From Education

- Where the school places a child with an alternative provision provider, it continues to be responsible for the safeguarding of that child. This includes the school:
 - having records of the address of the alternative provider and any subcontracted provision or satellite sites the child may attend.
 - regularly reviewing (at least once each term – 6 to 7 weeks) the alternative provision placements made to provide assurance that the child is regularly attending and the placement continues to be safe and meets the child's needs.
- Where safeguarding concerns arise, placements will be immediately reviewed, and terminated, if necessary, unless or until those concerns have been satisfactorily addressed.

5.6 Elective Home Education (EHE)

- Where a parent/carer expresses their intention to remove a child from school with a view to educating at home, we will respond in line with national Elective Home Education guidance and local Kent guidance.
- We will work together with parents/carers and other key professionals and organisations to ensure decisions are made in the best interest of the child.
- **Due to the heightened vulnerability of the children at Laleham Gap School, safeguarding concerns within the home environment are taken seriously when considering Elective Home Education. Where such concerns exist, the school will notify the Local Authority and share all relevant information that may influence decisions regarding a child's suitability for EHE. This is done in accordance with statutory safeguarding duties and in the best interests of the child.**
- For children who are already being educated at home, this may involve working with the Local Authority and other professionals to review or potentially cease EHE arrangements if they are deemed to compromise the child's safety or wellbeing.

5.7 Children who may benefit from Early Help

- Any child may benefit from early help, but all staff should be particularly alert to the potential need for early help for a child who:
 - o is disabled or has certain health conditions and has specific additional needs
 - o has special educational needs (whether or not they have a statutory Education, Health and Care plan)
 - o has a mental health need
 - o is a young carer
 - o is showing signs of being drawn in to anti-social or criminal behaviour, including gang involvement and association with organised crime groups or county lines
 - o is frequently missing/goes missing from education, home or care,
 - o has experienced multiple suspensions, is at risk of being permanently excluded from schools, colleges and in Alternative Provision or a Pupil Referral Unit.
 - o is at risk of modern slavery, trafficking, sexual and/or criminal exploitation
 - o is at risk of being radicalised or exploited
 - o has a parent or carer in custody, or is affected by parental offending
 - o is in a family circumstance presenting challenges for the child, such as drug and alcohol misuse, adult mental health issues and domestic abuse
 - o is misusing alcohol and other drugs themselves
 - o is at risk of so-called 'honour'-based abuse such as Female Genital Mutilation or Forced Marriage
 - o is a privately fostered child.
- Where it is identified a child may need early help, staff and DSLs will respond in line with section 3 of this policy.

5.8 Children who need a Social Worker (child in need and child protection plans)

- The DSL will hold details of social workers working with children in the school so that decisions can be made in the best interests of the child's safety, welfare, and educational outcomes.
- Where children have a social worker, this will inform school decisions about their safety and promoting their welfare, for example, responding to unauthorised absence and provision of pastoral and/or academic support.

5.9 Looked after children (including kinship care), previously looked after children and care leavers

- Laleham Gap School recognises the common reason for children becoming looked after is as a result of abuse, neglect and/or exploitation, and a previously looked after child also potentially remains vulnerable.

The school has appointed a '[designated teacher](#)' who works with local authorities, including the [Virtual School Kent \(including the virtual school head\)](#), to promote the educational achievement of registered learners who are looked after or who have been previously looked after, including those in [kinship care](#).

- The designated teacher will work with SLT and DSLs to ensure appropriate staff have the information they need in relation to a child's looked after legal status, contact arrangements with birth parents or those with parental responsibility, care arrangements and the levels of authority delegated to the carer by the authority looking after them.
- Where a child is looked after, the DSL will hold details of the social worker and the name of the virtual school head in the authority that looks after the child.
- Where the school believe a child is being cared for as part of a private fostering arrangement (occurs when a child under 16 or 18 if the child is disabled is cared for and lives with an adult who is not a relative for 28 days or more) there is a duty to recognise these arrangements and inform the Local Authority via the front door.
- Where a child is leaving care, the DSL will hold details of the local authority Personal Advisor appointed to guide and support them and will liaise with them as necessary regarding any issues of concern.

5.10 Children who are privately fostered

- [Private fostering](#) occurs when a child under the age of 16 (under 18 for children with a disability) is provided with care and accommodation by a person who is not a parent, person with parental responsibility for them or a relative in their own home. A child is not privately fostered if the person caring for and accommodating them has done so for less than 28 days and does not intend to do so for longer.
- Where private fostering arrangements come to the attention of the school, for example, through the normal course of their interaction and promotion of learning activities with children, we must notify Kent Integrated Children's Services in line with the local [KSCMP arrangements](#) in order to allow the local authority to check the arrangement is suitable and safe for the child.

5.11 Children who are Lesbian, Gay, Bisexual, or Gender Questioning

- The fact that a child may be lesbian, gay, bisexual or gender questioning is not in itself an inherent risk factor for harm, however, Laleham Gap School recognises that children who are lesbian, gay, bisexual or gender questioning or are perceived by other children to be lesbian, gay, bisexual or gender questioning (whether they are or not) can be targeted by other children or others within the wider community.
- When supporting a trans or gender questioning child, the school will consider the broad range of their individual needs, in partnership with the child's parents (other than in the exceptionally rare circumstances where involving parents would constitute a significant risk of harm to the child), including any clinical advice that is available and how to address wider vulnerabilities such as the risk of bullying.
- Laleham Gap School recognises risks can be compounded where children who are lesbian, gay, bisexual or gender questioning lack a trusted adult with whom they can be open. Appropriate education is included within our Relationships Education/ Relationship and Sex Education and Health Education curriculum, and our staff will endeavour to reduce the additional barriers faced and provide a safe space that facilitates a culture where children can speak out or share any concerns.
- **All children at Laleham Gap School are taught about Children's Rights, which includes the right to an identity and the right to personal beliefs.**

6. Online Safety

- It is essential that children are safeguarded from potentially harmful and inappropriate material or behaviours online. Laleham Gap School will adopt a whole school approach to online safety which will empower, protect, and educate our learners and staff in their use of technology, and establish mechanisms to identify, intervene in, and escalate any concerns where appropriate.
- This section highlights key online safety information, but Laleham Gap School has a separate Online Safety Policy where more in depth information on our Online Safety practices can be found. This section includes guidance new guidance on Generative Artificial Intelligence, mobile and smart technologies and responsibilities and further filtering and monitoring guidance.
- Laleham Gap School will ensure online safety is reflected as required in all relevant policies. Including:
 - Online Safety Policy
 - Staff Acceptable Use Policy
 - Student Mobile Device Agreements
- Online safety is considered as a running and interrelated theme when devising and implementing our policies and procedures and when planning our curriculum, staff training, the role and responsibilities of the DSL and parental engagement.

- Laleham Gap School identifies that the breadth of issues classified within online safety is considerable, but can be categorised into four areas of risk:
 - **Content:** being exposed to illegal, inappropriate, or harmful content, for example: pornography, racism, misogyny, self-harm, suicide, anti-Semitism, radicalisation, extremism, misinformation, disinformation (including fake news) and conspiracy theories, **including media and materials created by generative AI.**
 - **Contact:** being subjected to harmful online interaction with other users. For example peer to peer pressure, commercial advertising and adults posing as children or young adults with the intention to groom or exploit them for sexual, criminal, financial or other purposes.
 - **Conduct:** personal online behaviour that increases the likelihood of, or causes, harm. For example, making, sending and receiving explicit images (e.g. consensual and non-consensual sharing of nudes and semi-nudes and/or pornography), sharing other explicit images, **including those generated by AI,** and online bullying.
 - **Commerce:** risks such as online gambling, inappropriate advertising, phishing and or financial scams.
- Laleham Gap School recognises that technology, and the risks and harms related to it, evolve and change rapidly. The school will carry out an annual review of our approaches to online safety, supported by an annual risk assessment which considers and reflects the risks our children face.
- The Headteacher will be informed of online safety concerns by the DSL, as appropriate. The named governor for safeguarding will report on online safety practice and incidents, including outcomes, on a regular basis to the wider governing body. Incidents are explored as part of our Termly Safeguarding Reviews.
- All staff must be aware that **the DSL has overall responsibility for online safety** within the school but will liaise with other members of staff, for example our School Network Manager, CEOP Ambassador, Headteacher and curriculum leads as necessary.
- The DSL will respond to online safety concerns in line with our child protection and other associated policies, such as our Anti-bullying Policy and Acceptable Use Policies.
 - Internal support such as interventions and/or sanctions will be implemented as appropriate. Educating children regarding online safety is always our first approach, but, repeat or serious incidents will be addressed as appropriate.
 - Where necessary, concerns will be escalated and reported to relevant partner agencies in line with local policies and procedures, for example, Childrens Integrated Services or the Police.

6.1 Generative Artificial Intelligence

Laleham Gap School is committed to the safe, ethical, and educational use of generative artificial intelligence. We recognise both the opportunities and the risks that AI presents in a school setting and will continue to monitor developments in technology, legislation, and safeguarding guidance. Through robust policies, ongoing staff training, and a culture of accountability, we aim to ensure that AI is used to enhance learning and support our community without compromising safety, privacy, or integrity. This unyielding commitment shapes this section of our Child Protection Policy.

- Laleham Gap School recognises that when used safely, effectively and with the right infrastructure in place (e.g. appropriate filtering, monitoring, staff training and data protection protocols), **generative artificial intelligence (AI) tools have many uses which could benefit our entire school community.**
- Staff should recognise and understand that the use of AI is encouraged by the UK Government in safe and appropriate ways and is outlined in the [Government's AI Opportunities Action Plan](#) and is core to delivering the governments missions.
- However, the UK currently has the third largest AI market in the world, and along with its benefits, it is also important to recognise that AI tools can also pose significant safeguarding risks to our community as well as moral, ethical and legal concerns. This includes, but is not limited to:
 - exposure to inappropriate or harmful content, including bullying, harassment, abuse and exploitation
 - privacy and data protection breaches/risks
 - intellectual property infringements
 - academic integrity challenges such as plagiarism and cheating
 - exposure to inaccurate, misleading, or biased content.
 - the creation of harmful content such as discriminatory, violent, or sexually explicit material, particularly materials involving or exposed to learners.
- Staff must be aware that even AI-generated content can cause harm if it mimics real individuals or situations. Staff should also understand that risks posed by AI can be significantly amplified when used irresponsibly or maliciously by individuals or organisations lacking appropriate training or ethical standards.
- Laleham Gap School only permits the use of generative AI tools which have been approved and provided by the school for work and/or educational purposes, following the Senior Leadership Team undertaking risk assessments and/or data protection impact assessments prior to use. At present, the school only approves the use of Microsoft Copilot due to its enterprise level data protection. Staff should understand this is because copilot automatically disables prompt learning and stores data within UK/EU zones. This ensures that sensitive school data is not used to train external models, remaining GDPR compliant.

- Laleham Gap School operates with caution around updates which force the introduction of AI features. For example, Microsoft AI features that will be embedded in Office applications in the near future will be reviewed for compliance. If they cannot be disabled until appropriate assurances regarding data protection and compliance are published or received, staff must seek approval before use. This is to prevent data becoming unprotected by GDPR and potentially being subject to foreign laws such as the US Patriot Act. It also includes ensuring that embedded AI features do not bypass school filtering or monitoring systems.
- Staff at Laleham Gap School also permitted to use **Google Notebook LM** for research or Retrieval Augmented Generation with curriculum materials such as large schemes of work, but, **must not use any other school documents or individuals' private data within this AI tool**. Anonymised curriculum data may also be included if it is compliant with our data protection policy and national data protection standards.
 - It is Staff responsibility to ensure that any curriculum data they use with AI is anonymised and does not include learner identifiers.
- Any generative AI material must be checked in its entirety by the member of staff using it to ensure there are no errors or offensive materials with the output. Staff must retain accountability for any AI-generated content used in teaching or communication.
- **Staff must not rely solely on AI-generated outputs for decision-making or communications.**
- Where AI tools have been approved for use, staff are recommended to turn off the option for AI tools such as large language models to learn from their prompts and documents for anything work related. Where this option is not available, staff must not use the tool for sensitive or identifiable data. This includes learner names, SEND information, medical data, and safeguarding records.
- Staff and learners will both be made aware of the benefits and risks of using generative AI tools and the school expectations through:
 - Staff CPD sessions covering generative AI and its emerging use cases and risks.
 - Curriculum content which educates both learners and staff in the safe use of AI and the dangers it poses.
 - Staff acceptable use policy which has clear boundaries around the use of generative AI.
 - Guidelines on how staff can support learners understanding of generative AI.
 - Events with speakers who have specialist knowledge in this field and can share their expertise with staff and learners.
 - Engagement with local DSL and safeguarding networks so that all staff have up to date knowledge on the benefits and the risks of using AI in school settings.
 - [Sharing government guidance](#) on the use of generative AI in schools.
 - AI safety as part of digital literacy education for learners.
- Staff can access training regarding the benefits and risks of AI via our National College portal.

- Staff are required to carry out a risk assessment and seek written approval from the Senior Leadership Team prior to any use of AI in Laleham Gap School, especially if it is being used in lessons and/or with learners. This includes any AI use that involves learner data, learner interaction, or public-facing outputs. The exception to this is the pre-agreed use of Microsoft Copilot Enterprise Edition.
- Laleham Gap School will respond to any misuse of AI in line with relevant policies, including but not limited to, anti-bullying, behaviour, data protection, complaints, acceptable use and child protection.
- Staff who choose to use AI tools not approved by the school do so at their own risk. Data breaches, including processing of sensitive data outside school guidelines and GDPR-compliant zones, may result in disciplinary action and/or breach of data protection law.
- Staff must report any suspected misuse of AI to the DSL or Data Protection Officer immediately.
- Where the School believe that AI tools may have facilitated the creation of child sexual abuse material, the school will respond in line with existing local safeguarding procedures and [national guidance](#) from the IWF and NCA-CEOP.
- Where the School are responding to concerns regarding digitally manipulated and AI-generated nudes and semi-nudes, the school will respond in line with section 4.3 of this policy and the local [KSCMP](#) safeguarding procedures and UKCIS '[Sharing nudes and semi-nudes: advice for education settings working with children and young people](#)' guidance. However, Laleham Gap take a clear stance on child imagery and the **creation of child sexual abuse material, even if artificial, is an offence. This aligns with guidance from the Internet Watch Foundation and the National Crime Agency. If any member of staff or an adult within our community is found to create this material, they will be reported to the police immediately.** In the event that a staff member was involved in the production of such material, additional actions such as reports to the LADO and professional regulatory agencies will also be made.
- Staff must not attempt to investigate or download suspected material. They must alert the DSL and all concerns must be escalated immediately.
- Staff must report any suspected deepfake abuse to the DSL and follow whistleblowing procedures if internal concerns arise. Where the School believe that AI tools may have facilitated [deep fake](#) abuse of adults, advice and support will be provided to individuals affected, such as via Unions, [Professionals Online Safety Helpline](#) or [Report Harmful Content](#) and/or if a crime has been committed, via the [police](#). Action will be taken in line with relevant School policies, including but not limited to, anti-bullying, behaviour and complaints.
- Staff should be aware of the emotional impact of deepfake abuse and signpost affected individuals to mental health support services.

- Any member of staff using AI in school must be aware of [Ofsted's guidance on the use of AI](#), including its expectations around transparency, safeguarding, and educational impact.
 - Ofsted expects schools to have considered the use of AI seriously, even if it is not yet mandatory. Staff must understand how AI tools may affect outcomes for learners and be able to demonstrate safe, ethical, and purposeful use.
 - Ofsted may ask how AI is being used to support or hinder safeguarding, curriculum delivery, and staff workload. All staff must develop some understanding of this.
- All staff must recognise that AI tools and assistants are rapidly evolving. Staff are expected to develop their understanding of AI in line with technological advancements and emerging educational guidance. To support this, staff are encouraged to refer to the following resources:
 - [DfE Generative AI Guidance](#)
 - [KSCMP AI Factsheet](#)
 - [UKCIS Sharing Nudes Guidance](#)
 - [National College AI Training](#)
 - [NAIS - AI Resources for Schools and Educators](#) also provides a useful insight into different AI tools and use-cases.
- All Staff, particularly Leaders and Teachers, should regularly review updates from the DfE, Ofsted, and local safeguarding guidance to stay informed.

This section outlines the school's proactive approach to managing the opportunities and risks of generative AI. As technology continues to evolve, Laleham Gap School remains committed to reviewing and refining its practices to ensure AI is used responsibly, safely, and in the best interests of our learners and wider community.

6.2 Mobile and Smart Technology

- Laleham Gap School recognises the specific risks that can be posed by mobile and smart technology, including mobile/smart phones, cameras, wearable technology and any other electronic devices with imaging and/or sharing capabilities.
- In accordance with KCSIE and EYFS Laleham Gap has appropriate acceptable use policies and mobile device agreements in place, which are shared and understood by all members of the community. In the event of a breach of these policies, appropriate and proportionate action will be taken in line with the concern. First and foremost, we will always look to education both staff and learners about the safe use of mobile devices, but serious or repeated breaches could lead to disciplinary procedures.
- Staff must always refer to the Staff Acceptable Use Policy which should be read and signed upon appointment to a new role in the school and as the guidance is updated.

Further information reading the specific approaches relating to this can be found in our LGS14 Online Safety Policy. (This policy can be found on the school's website, Wellbeing Office Safeguarding Policy folder and online on the 'Whole School' drive within the 'Policies' folder.

6.3 Appropriate filtering and monitoring on school devices and networks

- Laleham Gap School will do all we reasonably can to limit children's exposure to online harms through school provided devices and networks and in line with the requirements of the Prevent Duty and KCSIE, we will ensure that appropriate filtering and monitoring systems are in place.
- **This includes ensuring application of appropriate filtering and monitoring to both static content, as well as dynamic and AI-generated materials, products and/or systems used.**
- When implementing appropriate filtering and monitoring, Laleham Gap School will ensure that "over blocking" does not lead to unreasonable restrictions as to what children can be taught with regards to online teaching and safeguarding.
- Whilst filtering and monitoring is an important part of our online safety responsibilities, it is only one part of our approach to online safety and we recognise that we cannot rely on filtering and monitoring alone to safeguard our learners; effective safeguarding practice, robust policies, appropriate classroom/behaviour management and regular education/training about safe and responsible use is essential and expected.
 - Learners will use appropriate search tools, apps and online resources as identified by staff, following an informed risk assessment and/or a data privacy impact assessment as relevant.
 - Internet use will be supervised by staff as appropriate to learners age, ability and potential risk of harm:
 - Physical monitoring (supervision).
 - Monitoring internet and web access (reviewing log file information).
 - Pro-active technology monitoring services – SECURUS and Sophos FastVue.
 - All users will be informed that use of our systems is monitored and that all monitoring will be in line with data protection, human rights and privacy legislation.

6.3.1 Responsibilities

- Our governing body has overall strategic responsibility for our filtering and monitoring approaches, including ensuring that our filtering and monitoring systems are regularly reviewed, and that the leadership team and relevant staff have an awareness and understanding of the appropriate filtering and monitoring provisions in place, manage them effectively and know how to escalate safeguarding concerns when identified.

- Joshua Payne, a member of the senior leadership team and Victoria Acors, Safeguarding Governor, are responsible for ensuring that our school has met the DfE Filtering and monitoring standards for schools and colleges.
- Our senior leadership team are responsible for
 - procuring filtering and monitoring systems.
 - documenting decisions on what is blocked or allowed and why.
 - reviewing the effectiveness of our provision.
 - overseeing reports.
 - ensuring that all staff understand their role, are appropriately trained, follow policies, processes and procedures and act on reports and concerns.
 - ensuring the DSL, Network Manager and IT Service Providers have sufficient time and support to manage their filtering and monitoring responsibilities.
- The DSL has lead responsibility for overseeing and acting on:
 - any filtering and monitoring reports.
 - any child protection or safeguarding concerns identified.
 - checks to filtering and monitoring system.
- The Network Manager have technical responsibility for:
 - maintaining filtering and monitoring systems.
 - providing filtering and monitoring reports.
 - completing technical actions identified following any concerns or checks to systems.
 - working with the Senior Leadership Team and DSL to procure systems, identify risks, carry out reviews and carry out checks.
 - providing the DSL with unrestricted access to monitoring systems (such as Securus and Sophos) to carry out their job effectively.
- All members of staff are provided with an understanding of the expectations, applicable roles and responsibilities in relation to filtering and monitoring as part of our induction process, and in our annual child protection staff training.
- All staff, learners and parents/carers have a responsibility to follow this policy to report and record any filtering or monitoring concerns.

6.3.2 Decision making and reviewing our filtering and monitoring provision

- When procuring and/or making decisions about our filtering and monitoring provision, our senior leadership team works closely with the DSL and the Network Manager.
- Decisions have been recorded and informed by an approach which ensures our systems meet our schools specific needs and circumstances, including but not limited to our learners risk profile which

considers the specific vulnerabilities (including age and ability), risk and context of our learners, and our school specific technology.

- Any changes to the filtering and monitoring approaches will be assessed by staff with safeguarding, educational and technical experience and, where appropriate, with approval from the leadership team; **all changes to the filtering policy are logged and recorded.**
- Our school undertakes regular (at least annual) reviews of our filtering and monitoring systems to ensure we understand the changing needs and potential risks posed to our community.
- In addition, our school undertakes regular checks on our filtering and monitoring systems, to ensure our systems work effectively in practice and as expected, and to provide assurance to the Governing Body that we are continuing to meet our safeguarding obligations. These checks are logged and recorded.
 - These checks are achieved by:
 - Reviewing Securus Logs
 - Reviewing guidance from SWGfL
 - Using an [SWGfL to test our filtering service](#).

6.3.3 Appropriate filtering

- Laleham Gap School's education broadband connectivity is provided through **Wave 9** and Laleham Gap School uses **Sophos to filter and block access harmful content**. Sophos also allows us to **track potentially harmful searches**, alerting the DSL and Network Manager to any searches of concern. **The DSL is granted unfiltered access to this tool.**
- Sophos filters and blocks school provided internet access to illegal content and activity as identified in the Online Safety Act, including:
 - Child Sexual Abuse Material (CSAM)
 - Controlling or coercive behaviour
 - Extreme sexual violence
 - Extreme pornography
 - Fraud
 - Racially or religiously aggravated public order offences
 - Inciting violence
 - Illegal immigration and people smuggling
 - Promoting or facilitating suicide
 - Intimate image abuse
 - Selling illegal drugs or weapons
 - Sexual exploitation
 - Terrorism
- **Sophos Fastview** is a safeguarding tool also allows us to **track potentially harmful searches**, alerting the DSL and Network Manager to any searches of concern. **The DSL is granted unfiltered access to this tool.**

- Wave 9 is a member of Internet Watch Foundation (IWF) and uses IWF services to block access to illegal content including child sexual abuse material (CSAM).
 - Wave 9 has signed up to Counter-Terrorism Internet Referral Unit list (CTIRU)
 - Wave 9 and Sophos blocks access to sites which could promote or include harmful and/or inappropriate behaviour or material. This includes content which promotes hate speech or discrimination, gambling, harmful bullying content, malware/hacking, mis-disinformation, privacy and copyright theft, pornography, self-harm and eating disorders and/or violence against women and girls.

Our filtering system is operational, up to date and applied to all users, including guest accounts, all school owned or provided devices, systems and networks, and all devices using the school internet connection.

- We filter internet use on all school owned, or provided, internet enabled devices and networks. This is achieved by:
 - Controlling device settings and routing traffic through the school Wi-Fi.
 - Guest Wi-fi is available at Laleham Gap School and is filtered using Sophos, which will block access to harmful and inappropriate material on other devices using the school's internet. By default, student level filtering is enabled on all guest devices.
- Our filtering system is operational, up to date and is applied to all users, including guest accounts, all school owned devices and networks, and all devices using the school broadband connection.
- We work with Wave 9 and our IT service providers and our Network Manager to ensure that our filtering policy is continually reviewed to reflect our needs and requirements.
- If there is failure in the software or abuse of the system, for example if learners or staff accidentally or deliberately access, witness or suspect unsuitable material has been accessed, then:
 - Learners must turn off their screen and report this to an appropriate members of staff immediately.
 - Staff members must report this to the Network Manager and the DSL immediately.
 - Learners and adults are encouraged to report the content to CEOP.
 - The Network Manager will request the appropriate URL is added to the filtering systems.
 - The DSL will gather information to decide the next steps.
 - Where deliberate abuse or access to inappropriate or harmful material occurs, the DSL must decide what further action is required.
 - Incidents involving staff members will be reported to the Headteacher immediately.
- Filtering breaches will be reported to the DSL and the Network Manager and will be recorded and escalated as appropriate and in line with relevant policies, including our child protection, acceptable use, allegations against staff and behaviour policies.
- Parents/carers will be informed of filtering breaches involving their child, unless to do so would put a child at risk of harm or compromise a criminal investigation.

- Any access to material believed to indicate a risk of significant harm, or that could be illegal, will be reported as soon as it is identified to the appropriate agencies, including but not limited to the [Internet Watch Foundation](#) (where there are concerns about child sexual abuse material), [Kent Police](#), [NCA-CEOP](#) or [Kent Integrated Children's Services via the Kent Integrated Children's Services Portal](#).
- If staff are teaching topics which could create unusual activity on the filtering logs, or if staff perceive there to be unreasonable restrictions affecting teaching, learning or administration, they will report this to the DSL and/or leadership team.

6.3.4 Appropriate Monitoring

- We will appropriately monitor the use of all school provided devices and networks to detect safeguarding risks in real or near-real time, including accessing or attempting to access, or engaging with or attempting to engage with illegal and/or harmful/inappropriate content or activity by any user. This is achieved by:
 - Ensuring learners use appropriate search tools, apps and online resources as identified by staff, following an informed risk assessment.
 - Staff supervising internet use as appropriate to learners age, ability and potential risk of harm:
 - Physical monitoring (supervision).
 - Monitoring internet and web access (reviewing log file information).
 - Pro-active technology monitoring services such as Sophos, Sophos Fastview and SECURUS.
- All users will be informed that use of our systems is monitored and that all monitoring will be in line with data protection, human rights and privacy legislation.
- If a concern is identified via our monitoring approaches:
 - Where the concern relates to learners, it will be reported to the DSL and will be recorded and responded to in line with relevant policies, such as child protection, acceptable use, and behaviour policies.
 - Where the concern relates to staff, it will be reported to the headteacher (or chair of governors if the concern relates to the headteacher), in line with our 'Staff Handbook' and 'Managing Allegations Against Staff' policy.
- Parents/carers will be informed of safeguarding concerns involving their child identified through our monitoring approaches, unless to do so would put a child at risk of harm or compromise a criminal investigation.
- Where our monitoring approaches detect any immediate risk of harm or illegal activity, this will be reported as soon as possible to the appropriate agencies; including but not limited to, the

emergency services via 999, [Kent Police](#) via 101, [NCA-CEOP](#), LADO or [Kent Integrated Children's Services via the Kent Integrated Children's Services Portal](#).

6.4 Information Security and Access Management

- Laleham Gap School is responsible for ensuring an appropriate level of security protection procedures are in place, in order to safeguard our systems as well as staff and learners. Further information can be found in Acceptable use policy and Online Safety Policy.
- Laleham Gap School will review the effectiveness of these procedures periodically to keep up with evolving cyber-crime technologies.
- Joshua Payne, a member of the senior leadership team and Victoria Acors, Safeguarding Governor, are responsible for ensuring that our school has met the DfE [cyber security standards](#) for schools and colleges.

6.5 Remote/Online Learning

- All communication with learners and parents/carers will take place using school provided or approved communication channels; for example, school provided email accounts and phone numbers and/or agreed systems: Teams, Class Dojo and the 'School App'.
 - Any pre-existing relationships or situations which mean this cannot be complied with will be discussed with the DSL.
- Staff and learners will engage with remote teaching and learning in line with existing behaviour principles as set out in our school behaviour policy/code of conduct and Acceptable Use Policies.
- Staff and learners will be encouraged to report issues experienced at home and concerns will be responded to in line with our child protection and other relevant policies.

6.6 Staff Training

- Laleham Gap School will ensure that all staff receive online safety training, which, amongst other things, will include providing them with an understanding of the expectations, applicable roles and their responsibilities in relation to filtering and monitoring, as part of induction.
- Ongoing online safety training and updates for all staff will be integrated, aligned and considered as part of our overarching safeguarding and child protection approach. See section 7 for more information.

6.7 Educating Learners

- Laleham Gap School will ensure a comprehensive whole school curriculum response is in place to enable all learners to learn about and manage online risks effectively as part of providing a broad and balanced curriculum. This will include sharing informative materials with parents, offering online safety advice at parent coffee mornings and utilising resources from the [UK Council for Internet Safety \(UKCIS\) 'Education for a Connected World Framework'](#) and DfE ['Teaching online safety in school' guidance](#). See section 9 for more information.

6.8 Working with Parents/Carers

- Laleham Gap School will build a partnership approach to online safety and will support parents/carers to become aware and alert of the potential online benefits and risks for children by sharing guidance and information with parents and maintaining regular communication regarding any concerns, agreeing appropriate ways to address these. We will offer training and advice through parent events, our National Online Safety portal and our DSL/Online Safety Ambassador.
- Parents will be notified of Online Safety events occurring in school and will be sent supporting materials to explore at home. Additional resources will be available on the school website.
- Laleham Gap School will ensure parents and carers understand what systems are used to filter and monitor their children's online use at school, what their children are being asked to do online, including the sites they will be asked to access and who from the school (if anyone) their child is going to be interacting with online. This is achieved by:
 - Timetabling of online learning activities.
 - Sharing of secure links through existing communication channels e.g. via school e-mail, Microsoft Teams or Class Dojo.
 - Pre-notifications of any online meeting or interactive classes taking place.
 - Attendance of more than one member of school staff in each session (where possible) for safeguarding purposes.
- Where the School is made aware of any potentially harmful risks, challenges and/or hoaxes circulating online, national or locally, we will respond in line with the DfE ['Harmful online challenges and online hoaxes'](#) guidance to ensure we adopt a proportional and helpful response.

7. Staff Engagement and Expectations

7.1 Awareness, Induction and Training

- All members of staff have been provided with a copy of part one of the current version of 'Keeping Children Safe in Education' which covers safeguarding information for staff.
 - School leaders, including the DSL will read KCSIE in its entirety.
 - School leaders and all members of staff who work directly with children will read Annex B.

- All members of staff have confirmed that they have read and understood the national guidance shared with them. This is confirmed through participation monitoring and digital signatures on our National Online Safety portal, as well as part of their annual refresher training quiz.
- It is a requirement that all members of staff have access to this policy and sign to say they have read and understood its contents. All staff are expected to re-read this policy at least annually (and following any updates) to ensure they understand our expectations and requirements.
- All new staff and volunteers (including agency and third-party staff) receive safeguarding and child protection training (including online safety, which, amongst other things, will include ensuring an understanding of the expectations, applicable roles and responsibilities in relation to filtering and monitoring) to ensure they are aware of the school's internal safeguarding processes, as part of their induction. This training is regularly updated and is in line with advice from the local safeguarding partners and explores the Kent processes to follow. This is achieved by:
 - Providing Induction Training to at the beginning of each term for all new staff/volunteers who have been enrolled since the last induction.
- All staff members (including agency and third-party staff) will receive appropriate child protection training (including online safety) that is updated at least annually, to ensure they are aware of a range of safeguarding issues and how to report concerns.
 - Annual Child Protection training detailing KCSIE and local guidance updates are delivered during inset days at the beginning of each school year.
 - Key topics are addressed through professional development sessions and inset days.
 - Staff are assigned training watchlists to complete via our online platform. This is monitored by the DSL and Deputy Head to ensure that people complete this.
- All governors and trustees receive appropriate safeguarding and child protection (including online safety) training at induction. This training equips them with the knowledge to provide strategic challenge to test and assure that our safeguarding policies and procedures are effective and support the delivery of a robust whole school approach to safeguarding. This training is regularly updated and reported to the Headteacher, DSL and to the Clerk to the Governors.
- The DSL will ensure that all new staff and volunteers (including agency and third-party staff) receive safeguarding and child protection training (including online safety), including information to ensure they are aware of the school internal safeguarding processes, as part of their induction. This will be achieved through face-to-face induction sessions, provision of safeguarding leaflets and by completing our enhanced induction and training offer. This training is regularly updated and is in line with advice from the safeguarding partners. The Safeguarding Governor is also actively invited to all face-to-face safeguarding training sessions delivered in school.
- All staff members (including agency and third-party staff) will receive appropriate child protection training (including online safety) to ensure they are aware of a range of safeguarding issues; this training will be updated regularly with targeted refresher sessions in PDMs and key training will be

updated at least annually through training days, twilight sessions and our National Online Safety portal.

- Online safety training for staff will be integrated, aligned and considered as part of the whole school safeguarding approach and wider staff training and curriculum planning.
- In addition to specific child protection training, all staff will receive regular safeguarding and child protection updates, at least annually, to provide them with relevant skills and knowledge to safeguard children effectively.
- Laleham Gap School recognises the expertise that all staff build by undertaking safeguarding training and from managing safeguarding concerns on a daily basis and staff are encouraged to contribute to and shape school safeguarding arrangements and child protection policies.
- The DSL and Headteacher will provide an annual report to the governing body detailing safeguarding training undertaken by all staff and will maintain an up-to-date register of who has been trained. Electronic records of staff training will be available through the National Online Safety platform, with key safeguarding training being logged by the Safeguarding Administrator.
- Although the school has a nominated lead for the governing body (Victoria Acors), all members of the governing body will access appropriate safeguarding training which covers their specific strategic responsibilities on a regular basis. This will be monitored by the Headteacher, DSL and Clerk to the Governors.

7.2 Safer Working Practice

- Our school takes steps as outlined in this and other relevant policies to ensure processes are in place for staff that promote continuous vigilance, maintain an environment that deters and prevents abuse and challenges inappropriate behaviour.
- All members of staff are required to work within our clear guidelines on safer working practice as outlined in the school code of conduct.
- The DSL will ensure that all staff (including contractors) and volunteers are aware of the school expectations regarding safe and professional practice via the Safeguarding Leaflet for Visitors, Staff Code of Conduct and Staff Acceptable Use Policy (AUP).
- Staff will be made aware of the school behaviour management and physical intervention policies. Staff will manage behaviour effectively to ensure a good and safe educational environment and will have a clear understanding of the needs of all children. Physical interventions and/or use of reasonable force will be in line with our agreed policy and procedures and national guidance.

- All staff will be made aware of the professional risks associated with the use of social media and electronic communication (such as email, mobile phones, texting, social networking). Staff will adhere to relevant school policies including Code of Conduct and Acceptable Use Policies. The Headteacher and DSL will encourage governors and SLT/MLT to complete an 'Annual Certificate in Managing Online Reputation' to help ensure the that the school and its wider community maintains a positive online presence.

7.3 Supervision and Support

- The induction process will include familiarisation with child protection responsibilities and procedures to be followed if members of staff have any concerns about a child's safety or welfare.
- The school will ensure that members of staff who are working within the foundation stage are provided with appropriate supervision in accordance with the statutory requirements of Early Years Foundation Stage (EYFS).
- The school will provide appropriate supervision and support for all members of staff to ensure that:
 - All staff are competent to carry out their responsibilities for safeguarding and promoting the welfare of children
 - All staff are supported by the DSL in their safeguarding role.
 - All members of staff have regular reviews of their own practice to ensure they improve over time.
- Any member of staff affected by issues arising from concerns for children's welfare or safety can seek support from the DSL.
- The DSL will also put staff in touch with outside agencies for professional support if they so wish. Staff can also approach organisations such as their Union, the Education Support Partnership or other similar organisations directly.

8. Safer Recruitment and Allegations

8.1 Safer Recruitment and Safeguarding Checks

- Laleham Gap School is committed to ensure that it develops a safe culture and that all steps are taken to recruit staff and volunteers who are safe to work with our learners and staff.
 - Laleham Gap School will follow Part three, 'Safer recruitment' of Keeping Children Safe in Education and relevant guidance from The Disclosure and Barring Service (DBS).
 - The governing body and leadership team are responsible for ensuring that the school follows safe recruitment processes as outlined within the KCSIE guidance.
 - The governing body will ensure that there is at least one of the persons who conducts an interview has completed safer recruitment training.

- The Headteacher, DSL and Safeguarding Administrator will support the governing body and ensure that Safer Recruitment Training is refreshed regularly for those actively involved in interviewing.
- The school maintains an accurate Single Central Record (SCR) in line with statutory guidance.
- Laleham Gap School are committed to supporting the statutory guidance from the Department for Education on the application of the Childcare (Disqualification) Regulations 2009 and related obligations under the Childcare Act 2006 in schools.
- We advise all staff to disclose any reason that may affect their suitability to work with children including convictions, cautions, court orders, cautions, reprimands, and warnings.
- **Where Laleham Gap School places a learner with an alternative provision provider, we will:**
 - obtain written information from the alternative provision provider that appropriate safeguarding checks have been carried out on individuals working at the establishment, i.e., those checks that our school would otherwise perform in respect of our own staff.
 - obtain written confirmation that the alternative provider will inform the commissioning school of any arrangements that may put the child at risk (i.e. staff changes), so that the commissioning school can ensure itself that appropriate safeguarding checks have been carried out on new staff.
- Where the school organises work experience placements, we will follow the advice and guidance as identified in Part three of KCSIE.
- Where the school organises homestays as part of exchange visits, we will follow the advice and guidance as identified in Part three and Annex E of KCSIE.

8.2 Allegations/concerns raised in relation to teachers, including supply teachers, other staff, volunteers and contractors

- The school will respond immediately to any concerns or allegations about staff and these will be recorded and dealt with appropriately in line with Part Four of KCSIE and the [local Kent allegations arrangements](#), including discussions as necessary with the Local Authority Designated Officer (LADO).
 - In depth information can be found within our 'Managing Allegations against Staff – Including Low Level Concerns' and the Staff Code of Conduct. This can be found in the Safeguarding Policies File in the Staff Room and online on the Staff Teams Drive in the policies folder.

- Any concerns or allegations about staff will be recorded and dealt with in line with Part four of KCSIE and reported as appropriate in line with local [Kent allegations management arrangements](#).
- Where the Headteacher is unsure how to respond, for example if the school is unsure if a concern meet the harm 'thresholds', advice will be sought via the [LADO Education Safeguarding Advisory Service](#) enquiry form.
- After resolving or concluding allegations or low-level concerns about staff, the headteacher/principal, along with the [LADO](#), if involved, will review the case to identify lessons learned and any possible improvements.
- In the situation that the school receives an allegation relating to an incident that happened when an individual or organisation was using our premises for the purposes of running activities for children (for example community groups, sports associations, or service providers that run extra-curricular activities), we will follow our safeguarding policies and procedures, including informing the LADO.

8.2.1 Concerns that meet the 'harm threshold'

- Laleham Gap School recognises that it is possible for any member of staff, including volunteers, governors, contractors, agency and third-party staff (including supply teachers) and visitors to behave in a way that indicates a person would pose a risk of harm if they continue to work in their present position, or in any capacity with children in a school or college. This includes when someone has
 - behaved in a way that has harmed a child, or may have harmed a child and/or
 - possibly committed a criminal offence against or related to a child and/or;
 - behaved towards a child or children in a way that indicates he or she may pose a risk of harm to children; and/or
 - behaved or may have behaved in a way that indicates they may not be suitable to work with children.
- Allegations against staff which meet this threshold will be responded to and managed in line with Part four of KCSIE. **Allegations that meet the harm threshold will be referred immediately to the headteacher who will contact the LADO** to agree further action to be taken in respect of the child and staff member. The headteacher reserves the right to consult with the DSL or ask for their support if appropriate and/or necessary.
- In the event of allegations of abuse being made against the headteacher, staff are advised that allegations should be reported to the **Chair of Governors** who will contact the LADO.
- If staff are concerned that appropriate safeguarding action is not being taken following an allegation against a colleague, they are advised to follow our whistleblowing process and/or to contact the LADO directly themselves.

8.2.2 Concerns that do not meet the 'harm threshold'

- Laleham Gap School may also need to take action in response to 'low-level' concerns about staff, which typically would be behaviours which are inconsistent with our staff code of conduct, including inappropriate conduct outside of work and concerns that do not meet the allegations threshold. Our **'Managing Allegations Against Staff – Including Low Level Concerns Policy'**, highlights what a low-level concern is, the importance of sharing them and the confidential procedure to follow when sharing them. **Low-level concerns should be reported directly to the Headteacher, and should only be reported to the DSL in the Headteacher's absence.**
 - Laleham Gap School has an open and transparent culture in which all concerns about all adults working in or on behalf of the school are dealt with promptly and appropriately; this enables us to identify inappropriate, problematic or concerning behaviour early, minimise the risk of abuse and ensure that adults working in or on behalf of the school are clear about and act within appropriate professional boundaries, and in accordance with our ethos and values.
 - A 'low-level' concern does not mean that it is insignificant; a low-level concern is any concern that an adult working in or on behalf of the school may have acted in a way that is inconsistent with our staff code of conduct, including inappropriate conduct outside of work and does not meet the 'harm threshold' or is otherwise not serious enough to consider a referral to the LADO.
 - Low-level concerns may arise in several ways and from a number of sources. For example, suspicion, complaints, or allegations made by a child, parent or other adult within or outside of the organisation, or as a result of vetting checks.
 - Low-level concerns are still matters of staff conduct that should be shared confidentially in line with our code of conduct/whistling blowing policy to the Headteacher. If low level concerns are reported to the DSL or another Leader, they should inform the Headteacher in a timely fashion in line with the concern. The Headteacher may wish to consult the DSL to take a more collaborative decision making approach when dealing with low level concerns.
 - Where low-level concerns are reported to the school, the Headteacher will be informed of all low-level concerns and is the ultimate decision maker in respect of the response to all low-level concerns.
 - The Headteacher is responsible for sharing and liaising with [the LADO](#) enquiries officer.
 - Low-level concerns shared about supply staff and contractors will be shared with their employers so any potential patterns of inappropriate behaviour can be identified.

- If the school is in any doubt as to whether the information which has been shared about a member of staff as a low-level concern in fact meets the harm threshold, we will consult with [the LADO](#).
- Low-level concerns will be recorded in writing and reviewed so potential patterns of concerning, problematic or inappropriate behaviour can be identified. An electronic copy of the form is available on the staff drive. Hard copies are available in the Safeguarding Policies Folder in the Staff Room or at request from the DSL.
 - Records will be kept confidential and will be held securely and retained and in compliance with the Data Protection Act 2018 and the UK General Data Protection Regulation (UK GDPR) and other relevant policies and procedures (for example data retention policies). These are held confidentially by the Headteacher, until the time that member ends their employment. At which point, these will be confidentially destroyed.
 - Where a pattern is identified, the school will implement appropriate action, for example consulting with the LADO enquiry line and following our disciplinary procedures.

8.3 Safe Culture

- As part of our approach to safeguarding, the School has created and embedded a culture of openness, trust and transparency in which our values and expected behaviour as set out in our staff code of conduct are constantly lived, monitored and reinforced by all staff (including supply teachers, volunteers and contractors) and where all concerns are dealt with promptly and appropriately.
- Staff are encouraged and should feel confident to self-refer, if they have found themselves in a situation which could be misinterpreted, might appear compromising to others, and/or on reflection they believe they have behaved in such a way that they consider falls below the expected professional standards. This includes where concerns may be felt to be deliberately invented or malicious; such allegations are extremely rare and as such all concerns should be reported and recorded.
- All staff and volunteers should feel able to raise any concerns about poor or unsafe practice and potential failures in the school safeguarding regime. The leadership team at Laleham Gap School will take all concerns or allegations received seriously.
- All members of staff are made aware of the school Whistleblowing procedure. **It is a disciplinary offence not to report concerns about the conduct of a colleague that could place a child at risk.**
- Staff can access the NSPCC whistleblowing helpline if they do not feel able to raise concerns regarding child protection failures internally. Staff can call **0800 028 0285** (8:00 AM to 8:00 PM Monday to Friday) or email help@nspcc.org.uk
- Laleham Gap School has a legal duty to refer to the Disclosure and Barring Service (DBS) anyone who has harmed, or poses a risk of harm, to a child, or if there is reason to believe the member of staff has

committed one of a number of listed offences, and who has been removed from working (paid or unpaid) in regulated activity or would have been removed had they not left. The DBS will consider whether to bar the person.

- If these circumstances arise in relation to a member of staff at our school, a referral will be made as soon as possible after the resignation or removal of the individual in accordance with advice from the [LADO](#) and/or Schools Personnel Service. In any instance such as this, the School Business Manager, who is a member of the Senior Leadership Team, will be consulted to ensure school procedures are followed appropriately. They can also assist by finding appropriate Human Resources information, advice and support.

9. Opportunities to teach safeguarding

- Laleham Gap School will ensure that children are taught about safeguarding, including online safety, as part of providing a broad and balanced curriculum. This will include covering relevant issues through Relationships and Sex Education.
- We recognise that school play an essential role in helping children to understand and identify the parameters of what is appropriate child and adult behaviour, what is 'safe', to recognise when they and others close to them are not safe, and how to seek advice and support when they are concerned. Our curriculum provides opportunities for increasing self-awareness, self-esteem, social and emotional understanding, assertiveness and decision making so that learners have a range of age appropriate contacts and strategies to ensure their own protection and that of others.
- Laleham Gap School recognises the crucial role we have to play in preventative education. Preventative education is most effective in the context of a whole-school approach which prepares learners for life in modern Britain and creates a culture of zero tolerance for sexism, misogyny/misandry, homophobia, biphobic and sexual violence/harassment.
- Laleham Gap School has a clear set of values and standards, upheld and demonstrated throughout all aspects of school life which are underpinned by our behaviour policy and pastoral support system, as well as by a planned programme of evidence-based RSHE delivered in regularly timetabled lessons and reinforced throughout the whole curriculum. Our programme is fully inclusive and developed to be age and stage of development appropriate.
- Laleham Gap School recognise that a one size fits all approach may not be appropriate for all children, and a more personalised or contextualised approach, tailored to the specific needs and vulnerabilities of individual children might be needed, for example children who are victims of abuse, neglect or exploitation, and children with SEND.
- Our school systems support children to talk to a range of staff. Children will be listened to and heard, and their concerns will be taken seriously and acted upon as appropriate.

- Laleham Gap School recognises the value of external organisations and/or speakers visiting to provide useful information or to help enrich children's education. However, Laleham Gap will always assess the suitability of external organisations or speakers before granting them access to learners; this may include an assessment of the educational value, the age/ability appropriateness of content and whether relevant safeguarding checks will be required.

10. Physical Safety

10.1 Use of 'reasonable force'

- Laleham Gap School trains all staff in proactive and preventative measures to support children and minimise the need for physical intervention, including reasonable force. Our ethos is guided by **TRINA – There Really Is No Alternative**, which reflects our commitment to using restrictive measures only when absolutely necessary to prevent and safeguard members of our school community from harm.
- There may however be circumstances when it is appropriate for staff to use reasonable force to keep everyone safe. The term 'reasonable force' covers the broad range of actions used by staff that involve a degree of physical contact to restrict or restrain children. This can range from guiding a child to safety by the arm, to more extreme circumstances such as breaking up a fight or where a child needs to be restrained to prevent violence or injury. 'Reasonable' in these circumstances means 'using no more force than is needed'. [Staff in our school are trained in PROACT by qualified instructors](#), ensuring that any use of force is lawful, safe, and in line with the needs of our learners, including those with SEND.
- Further information regarding our approach and expectations can be found in our Positive Behaviour Policy and Positive Handling, Support and Intervention, which are underpinned by local guidance and DfEs ['Use of reasonable force in schools'](#) guidance.

10.2 The Use of Premises by Other Organisations

- Where our school facilities or premises are rented/hired out to organisations or individuals (for example to community groups, sports associations, and service providers to run community or extra-curricular activities) we will ensure that appropriate arrangements are in place to keep children safe.
 - Where those services or activities are provided under the direct supervision or management of our school staff, our existing arrangements for child protection, including this policy, will apply.
 - Where services or activities are provided separately by another body using the school facilities/premises, the Headteacher and Governing Body will seek assurance that the provider concerned has appropriate safeguarding and child protection policies and procedures in place (including inspecting these as needed); and ensure that there are arrangements in place for the provider to liaise with the school on these matters where appropriate. If this assurance is not achieved, an application to use premises will be refused.

- Safeguarding requirements will be included in any transfer of control agreement (such as a lease or hire agreement), as a condition of use and occupation of the premises. Failure to comply with this will lead to termination of the agreement.

10.3 Site Security

- All members of staff have a responsibility for maintaining awareness of buildings and grounds security and for reporting concerns that may come to light. This includes, but is not limited to:
 - Day to day procedures such as ensures gates, windows and doors are closed.
 - Staff and governor lanyards are worn.
 - Damaged or broken equipment and areas are reported to the School Business Manager and Site staff immediately – preferably verbally and by e-mail: site@lgs.kent.sch.uk
- Appropriate checks will be undertaken in respect of visitors and volunteers coming into school as outlined within national guidance. Visitors will be expected to, sign in and out via the office visitors log and to display a visitor's badge whilst on site. Staff have a responsibility to support leaders with this by:
 - Ensuring visitors arriving on site are signposted to the school office to sign in and have been provided with the appropriate information and lanyards.
 - Ensuring visitors without an appropriate DBS are escorted around the site and are monitored throughout their stay.
 - Raise any concerns about visitors with the DSL and/or Headteacher immediately.
 - Visitors leave the site as planned.
- Staff and visitors will be expected to adhere to any safety arrangements implemented due to safety concerns or nation guidance e.g. Covid-19 restrictions.
- Any individual who is not known or identifiable on site should be challenged for clarification and reassurance. Children should report any concerns to a member of staff.
- The school will not accept the behaviour of any individual (parent or other) that threatens school security or leads others (child or adult) to feel unsafe. Such behaviour will be treated as a serious concern and may result in a decision to refuse access for that individual to the school site.

11. Local Support

- All members of staff in Laleham Gap School are made aware of local support available.

Appendix 1: Categories of Abuse

All staff should be aware that abuse, neglect, exploitation and other safeguarding issues are rarely standalone events that can be covered by one definition or label. In most cases multiple issues will overlap with one another.

Abuse: a form of maltreatment of a child. Somebody may abuse or neglect a child by inflicting harm, or by failing to act to prevent harm. Abuse can be carried out both on and offline and be perpetrated by men, women, and children.

Sexual abuse: involves forcing or enticing a child or young person to take part in sexual activities, not necessarily involving a high level of violence, whether or not the child is aware of what is happening. The activities may involve physical contact, including assault by penetration (for example rape or oral sex) or non-penetrative acts such as masturbation, kissing, rubbing, and touching outside of clothing. They may also include non-contact activities, such as involving children in looking at, or in the production of, sexual images, watching sexual activities, encouraging children to behave in sexually inappropriate ways, or grooming a child in preparation for abuse (including via the internet). Sexual abuse is not solely perpetrated by adult males. Women can also commit acts of sexual abuse, as can other children.

Signs that MAY INDICATE Sexual Abuse

- Sudden changes in behaviour and performance
- Displays of affection which are sexual and age inappropriate
- Self-harm, self-mutilation or attempts at suicide
- Alluding to secrets which they cannot reveal
- Tendency to cling or need constant reassurance
- Regression to younger behaviour for example thumb sucking, playing with discarded toys, acting like a baby
- Distrust of familiar adults e.g. anxiety of being left with relatives, a childminder or lodger
- Unexplained gifts or money
- Depression and withdrawal
- Fear of undressing for PE
- Sexually transmitted disease
- Fire setting

The [Centre of Expertise on Child Sexual Abuse](#) provides resources to help education professionals identify and respond to concerns of child sexual abuse and abusive behaviours.

Physical abuse: a form of abuse which may involve hitting, shaking, throwing, poisoning, burning or scalding, drowning, suffocating or otherwise causing physical harm to a child. Physical harm may also be caused when a parent or carer fabricates the symptoms of, or deliberately induces, illness in a child.

Signs that MAY INDICATE physical abuse

- Bruises and abrasions around the face
- Damage or injury around the mouth

- Bi-lateral injuries such as two bruised eyes
- Bruising to soft area of the face such as the cheeks
- Fingertip bruising to the front or back of torso
- Bite marks
- Burns or scalds (unusual patterns and spread of injuries)
- Deep contact burns such as cigarette burns
- Injuries suggesting beatings (strap marks, welts)
- Covering arms and legs even when hot
- Aggressive behaviour or severe temper outbursts.
- Injuries need to be accounted for. Inadequate, inconsistent, or excessively plausible explanations or a delay in seeking treatment should signal concern.

Emotional abuse: the persistent emotional maltreatment of a child such as to cause severe and adverse effects on the child's emotional development. It may involve conveying to a child that they are worthless or unloved, inadequate, or valued only insofar as they meet the needs of another person. It may include not giving the child opportunities to express their views, deliberately silencing them or 'making fun' of what they say or how they communicate. It may feature age or developmentally inappropriate expectations being imposed on children. These may include interactions that are beyond a child's developmental capability as well as overprotection and limitation of exploration and learning, or preventing the child participating in normal social interaction. It may involve seeing or hearing the ill-treatment of another. It may involve serious bullying (including cyberbullying), causing children frequently to feel frightened or in danger, or the exploitation or corruption of children. Some level of emotional abuse is involved in all types of maltreatment of a child, although it may occur alone.

Signs that MAY INDICATE emotional abuse

- Over reaction to mistakes
- Lack of self-confidence/esteem
- Sudden speech disorders
- Self-harming
- Eating Disorders
- Extremes of passivity and/or aggression
- Compulsive stealing
- Drug, alcohol, solvent abuse
- Fear of parents being contacted
- Unwillingness or inability to play
- Excessive need for approval, attention, and affection

Neglect: the persistent failure to meet a child's basic physical and/or psychological needs, likely to result in the serious impairment of the child's health or development. Neglect may occur during pregnancy as a result of maternal substance abuse. Once a child is born, neglect may involve a parent or carer failing to: provide adequate food, clothing, and shelter (including exclusion from home or abandonment); protect a child from physical and emotional harm or danger; ensure adequate supervision (including the use of inadequate care-givers); or ensure access to appropriate medical care or treatment. It may also include neglect of, or unresponsiveness to, a child's basic emotional needs.

Signs that MAY INDICATE neglect.

- Constant hunger
- Poor personal hygiene
- Constant tiredness
- Inadequate clothing
- Frequent lateness or non-attendance
- Untreated medical problems
- Poor relationship with peers
- Compulsive stealing and scavenging
- Rocking, hair twisting and thumb sucking
- Running away
- Loss of weight or being constantly underweight
- Low self esteem
